NOTICE OF INTENT TO ACT UPON A REGULATION and NOTICE OF HEARING FOR THE ADOPTION OF REGULATIONS

The Nevada Transportation Authority ("Authority") will hold a public hearing at 9:00am on Friday, September 11, 2015. The public may attend the hearing at the following locations:

The purpose of the hearing is to receive comments from all interested persons and for the Authority to take action regarding the adoption of certain regulations to a new chapter of the Nevada Administrative Code for purposes of implementing Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session. The proposal has been designated as Docket 15-06024 by the Authority and as File No. R029-15 by the Nevada Legislative Counsel Bureau.

The following information is provided pursuant to the requirements of NRS 233B.0603:

- 1. The proposed adoption of certain regulations to a new chapter of the Nevada Administrative Code are necessary to provide to ensure the safety, reliability and cost-effectiveness of the transportation services provided by drivers affiliated with transportation network companies in Nevada. The purpose of the proposed regulations are related to:
 - a) Establishing general provisions and definitions regarding the operations of transportation network companies and drivers in Nevada [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
 - b) Establishing provisions governing an application to the Authority for a permit to operate as a transportation network company [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
 - c) Establishing provisions relating to permits to operate as a transportation network company [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
 - d) Establishing provisions relating to identification of drivers for transportation network companies [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];

- e) Establishing provisions relating to the regulatory assessment for transportation network companies [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
- f) Establishing regulations regarding the general operations of transportation network companies [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
- g) Establishing regulations regarding the rates and services of transportation network companies [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
- h) Establishing regulations regarding drivers for transportation network companies [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
- i) Establishing regulations regarding inspection and maintenance of vehicles operated by drivers for transportation network companies [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
- j) Establishing regulations regarding the method of operation of transportation network companies [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session];
- k) Establishing regulations regarding the enforcement of statues and regulations applicable to transportation network companies and drivers [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session]; and
- l) Establishing rules of practice before the Authority in matters related to transportation network companies and drivers [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session].
- m) The estimated impact of the regulations:
- n) The proposed regulations will not have a significant adverse or beneficial economic impact upon the regulated industry, either immediately or long-term.
- a) The proposed regulations will have not a significant adverse or beneficial economic impact upon the public, either immediately or long-term.

The Authority notes that these assessments of impact are limited to the impacts of the proposed regulations themselves. While the new statutes authorizing the operation of transportation network companies in Nevada [Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session] may have certain impacts, the proposed regulations are not expected to significantly alter those impacts.

- 2. The Authority determined the impact on small business as required pursuant to NRS 233B.0608 by taking and analyzing written and verbal comments from the public and from businesses to be affected by the proposed regulations in public general session meetings on June 11, June 25, and June 29, 2015, and at public workshops on July 16 and July 23, 2015.
- 3. The Authority anticipates incurring additional enforcement and regulatory oversight expenses as a result of the proposed regulations. The Authority anticipates such expenses being met by revenue from application fees and the regulatory assessment.
- 4. The Authority is not aware of any overlap or duplication of the proposed regulations with any regulations of other state or local governmental agencies.
- 5. The proposed regulations are not required pursuant to federal law.

- 6. The proposed regulations are not more stringent than any federal regulation that regulates the same activity.
- 7. The proposed regulations implement the application fee and regulatory assessment fee established by Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session. The proposed regulations do not otherwise establish a new fee or increase an existing fee.

Pursuant to NRS 233B.064: Upon adoption of any regulation, the agency, if requested to do so by an interested person, either prior to adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption, and incorporate therein its reason for overruling the consideration urged against it adoption.
