











Utah's Policy Journey | Highway Use Growing




Utah's Policy Journey | Revenue Not Keeping Pace



*Fuel Tax Revenue Index Baseline Normalized to 2003 Highway Construction Cost Index




Utah's Policy Journey | Vehicle Efficiency Growing

Based on 2019 tax rate





*Fees are graduated from 2019-21 and indexed to CPI after 2021








How Does the System Work?



SB 150 Transportation and Governance Funding Adopted 2020 General Session

By June 2021 a plan to enroll <u>all</u>* Utah-registered vehicles in program by December 2031
