The following work session document contains a compilation of selected recommendations for Bill Draft Requests (BDRs) or other suggestions that were submitted at hearings, in either oral or written form, during the course of the Fundamental Review. The committee may accept, reject, modify, or take no action on any of the proposals.

It was anticipated at the beginning of the Fundamental Review process that the examination of the ideas and concepts presented would continue beyond this legislative interim. The Steering Committee was tasked with the monitoring of the basic, major, and interagency reviews of state agencies; the evaluation of the suggestions received to improve state government; and the development of recommendations for the Governor. It also requested and received Fundamental Review reports from the offices of the state's constitutional officers.

The approved recommendations that result from these deliberations may result in the preparation of either policy or budgetary BDRs, to be submitted to the 2001 Legislature; Executive Orders; administrative directives to Executive Branch agencies; or a need to obtain additional information on a particular topic. Members of the Steering Committee do not necessarily support or oppose the recommendations listed in this document, which are compiled and organized broadly by topic for members' review.

The Nevada Revised Statutes (NRS), the Nevada Administrative Code (NAC), the Interim Finance Committee (IFC), and the University and Community System of Nevada (UCCSN) are referenced herein by their respective acronyms. The list of secondary recommendations included at the end of this document may receive no formal consideration during the work session, although it will be forwarded to the Office of the Governor for further consideration during the next two years. That secondary list includes suggestions and recommendations that were received via the Internet web site or through other means. Most of the ideas and concepts reflected in the secondary section were not discussed during previous meetings of the committee but may become the subject of additional discussion as the Fundamental Review process continues over time.

ADMINISTRATIVE CONCEPTS

- 1. Review travel claim procedures to eliminate reimbursement delays and denials of necessary expenses incurred by personnel.
- 2. Prepare an analysis of converting all e-mail to Internet service, with the goal of eliminating Groupwise through the Department of Information Technology.
- 3. Conduct a needs assessment and develop a plan of implementation for centralization of the small regulatory functions within the Department of Business and Industry into a Division of Regulatory Services (including occupational licensing boards that may not be large enough to warrant staff and have expertise).
- 4. To ensure that the best interest of the state is being met, establish uniform criteria for appointments of members of state boards, panels, and commissions that are responsible for making subgrant/contract decisions.
- 5. Consider using a "hospitality" fund number for refreshments to be purchased for state agency public meetings, and specify items that could be provided at such meetings.
- 6. Evaluate all proprietary services, within an "If the program went away tomorrow, would a significant number of people notice" concept, provided by the state to justify continuation at an appropriate organizational level for services, i.e., state or local government, nonprofit organization, private sector.
- 7. Consider limiting each state board to a single bill draft request, and eliminate the review by the Governor's office so that the request may be submitted early in the process.
- 8. Require contractors proposing to do business with the state to provide financial disclosure, membership of corporate boards, legal counsel, etc.
- 9. When privatization is considered, allow state agencies to "bid" against contractors.
- 10. Develop a formal procedure/system for the cost-benefit analysis for the provision of services by the state, versus contracting for services.
- 11. Evaluate the State Administrative Manual for requirements for contracts (specifically amendments) to determine if they need to be strengthened.
- 12. Review the stale claims process, including balance forward of stale claim money so it is not exhausted, e.g., Medicaid, Prison Medical, and Forestry.
- 13. Establish a procedure for the Legislative Counsel Bureau to reimburse Executive Branch agencies for providing basic research services to them.
- 14. Solicit legislative cooperation on the identification of nonbase items as part of the legislative closing process, e.g., letter of intent from the 1999 Legislature concerning the use of gas pollution funds.
- 15. Consider the consolidation of certain counties in an effort to eliminate some of the tax problems.
- 16. Consider a one-time appropriation to the Supreme Court for the preparation of a business plan for the establishment of a Business Court. (See SCR 19 Business in Nevada, BDR 253.)
- 17. Consider authorizing the transfer of the Medical Dental Screening Panel function from the Department of Business and Industry to the Office of the Attorney General.
- 18. Consider aggressively pursuing alternative programs, including use of private providers, enabling technologies, and mail service for the motor vehicle licensing and registration functions. (This is currently being evaluated.)

BUDGETARY CONCEPTS

- 19. Since base and maintenance decision units represent a major portion of the final *Executive Budget*, explore the possibility of agencies submitting only base and maintenance budget requests; enhancements would be narrative only with budgets established by the Budget Office only after a determination is made that funds are available and the Governor supports the proposal.
- 20. Require all agencies to prioritize programs that are supported by an appropriation to indicate what budget reductions it could sustain and not decrease services more than 20 percent.
- 21. Establish the protocol and procedures for Department of Information Technology involvement in the budget process to provide more accurate/appropriate guidance to agencies.
- 22. Include in the Budget Instructions specific requirements and examples for furnishing funding maps for budgets with multiple revenue sources (including calculations for federally mandated administrative spending limits and related measures) and for federal revenue streams (including the accumulated administrative spending authority).
- 23. Within statutory authority, maximize use of the tobacco settlement revenue for all new social service programs.
- 24. Create statutory meeting dates for Interim Finance Committee and Board of Examiners meetings, e.g., the third Thursday of the last month of each quarter for IFC.
- 25. To increase the time allotted to the Governor recommend phase, roll the agency request phase on or before September 1. (This means that if an agency does not comply with budget instructions for the proper placement of requests, the matter will be "corrected" in the governor's recommendation phase.)
- 26. Explore programs that could be funded through the State Highway Fund rather than the State General Fund.
- 27. Evaluate the possibility of combining the accounting and reporting functions related to the two federal revolving funds by considering the elimination of one accounting staff (e.g., the EPA fund or the clean drinking water fund), thereby reducing administrative costs for such similar programs.
- 28. Develop a uniform method for the justification of M200 budget requests for those agencies that do not have specific caseload-driven programs.
- 29. To prevent recurrence of past confusion and mistakes, develop written procedures for the establishment of recommended internal service and fringe benefit rates.
- 30. Evaluate legality and effectiveness of NRS provisions relative to stale claims for state checks to avoid difference in handling between the accounting and budgeting processes.
- 31. As part of the base budget review process, remove the value of any equipment charged to budget category 04 that was purchased for new full-time employees.
- 32. Redesign the work program form, including updating the preparation and support requirements in the procedural manual, and replace the cover sheet with a memo of explanation.
- 33. Review use of Commission on Tourism funds.
- 34. In the *Executive Budget*, consider consolidating accounts that were created for accounting purposes.
- 35. Consolidate the budget allocations for the Commission for Holocaust Education with the Governor's Executive Budget.

BUSINESS AND INDUSTRY CONCEPTS

- 36. Evaluate the feasibility of transferring the manufactured housing function to county building and community development departments.
- 37. Evaluate the advantages and disadvantages of combining consumer affairs functions of the Attorney General (NRS 228.310) and the Consumer Affairs Division (NRS 232.510) of Department of Business and Industry.
- 38. Evaluate the feasibility of transferring the Economic Development function to the Department of Business and Industry.
- 39. Publish the results of the Weights and Measures' testing of scanners.
- 40. Consider creating the Taxicab Authority, to include certain limousine regulatory functions from the Transportation Services Authority, as a regional service authority, and consider transferring the responsibility for remaining functions of the TSA to the Department of Public Safety, Highway Patrol Division.
- 41. As an alternative to the foregoing suggestion, consider consolidating the functions of the Taxicab Authority and the Transportation Services Authority into a single entity.
- 42. Evaluate the transfer of the responsibility for cemeteries and mausoleums (NRS 462) to the State Board of Funeral Directors, Embalmers, Operators of Cemeteries and Crematories and the county building departments.
- 43. Consider transferring the common-interest community function of the Real Estate Division to county governments. (See Titus BDR 63 and Schneider BDR 446.)
- 44. Consider transferring the Dairy Inspection Program from the State Board of Health to the State Dairy Commission.
- 45. Eliminate the federal regulatory activities of the Nevada Equal Rights Commission.
- 46. Eliminate the federal regulatory activities of the Labor Commissioner.
- 47. Eliminate the federal regulatory activities of the Division of Industrial Relations related to the occupational Safety and Health Administration regulations.
- 48. Consider the transfer of the industrial revenue bond program to the Housing Division if the division remains as a state agency.
- 49. Consider absorbing the Division of Industrial Relations into various agencies that provide similar functions and services.

CONSERVATION AND NATURAL RESOURCES CONCEPTS

- 50. Evaluate the success for in-house maintenance of the Lost City Museum Adobe.
- 51. Establish procedures for water district reimbursement of CNR administrative costs.
- 52. Evaluate the feasibility of transferring the administrative responsibility for the preservation and protection of wild horses in Nevada to a nonprofit organization.

- 53. Transfer the regulation of the commercial trade of cactus and yucca from the Division of Forestry to the Department of Agriculture. (Joint agreement between agencies.)
- 54. Consider eliminating the federal regulatory activities of Nevada's Division of Environmental Protection.
- 55. Consider support for the completion of the Natural Resources Master Plan as part of the state strategic planning effort.

EDUCATION CONCEPTS

- 56. Evaluate the feasibility of transferring the Legislative Bureau of Educational Accountability and Program Evaluation to the Department of Administration.
- 57. Evaluate the effectiveness of leadership in the University of Nevada, Reno, Admissions and Records and in Student Services to ensure fiscal responsibility.
- 58. Evaluate the inclusion of HCAP (medically underserved communities) in the WICHE (Western Interstate Commission for Higher Education) budget.
- 59. Consider a three- to five-year time line to phase in mandatory consolidation of school district subgrant applications for federal education funds under the Elementary and Secondary Education Act.
- 60. Evaluate changing existing small county school district boundaries, or create other alternatives, to address emerging operating and capital deficiencies.
- 61. Study possibility of funding bus operation and maintenance and driver training (K-12) costs through the State Highway Fund.
- 62. Establish a minimum financial support level required by registration and tuition fees for support of the instruction function of UCCSN campus budgets, e.g., several states require 25 to 30 percent of the cost to be supported by non-State General Fund (SGF) money.
- 63. Eliminate SGF support for UCCSN noninstructional programs, i.e., athletic programs.
- 64. Review the fee structure for the state licensure of private schools.
- 65. Consider the use of single request for proposal for local school districts to request state and federal funds and to obtain a global view of how these funds will be used to meet state academic accountability standards.
- 66. Evaluate the transfer of Project GAIN (Geographic Alliance of Nevada) and LEAD (Leadership for Nevada Educators) from the State Department of Education to the UNLV statewide.
- 67. Increase classroom contact time for University and Community College System of Nevada teachers.

STATE EQUIPMENT AND FACILITIES CONCEPTS

- 68. Evaluate the potential benefits and budgetary savings that might be realized through energy retrofit of state buildings to avert increases in utility expenses and realize savings in operation and maintenance costs.
- 69. Evaluate the benefit of placing old patrol cars at key, high-visibility locations to reduce the number of speeding

vehicles, i.e., between Carson City and Reno.

- 70. Eliminate the home storage of state vehicles unless complete justification can be made.
- 71. Include two-year cycle language in the appropriations/authorizations act so that first year funds for autos, buses, equipment, and so forth, would balance forward.
- 72. Centralize aircraft maintenance, e.g., is it feasible to expand existing forestry/wildlife program to include Nevada Department of Transportation and Highway Patrol aircraft?
- 73. Establish a policy for operation and maintenance of privately funded state building, e.g., minimum endowment, similar to Reynolds and Lied foundations, for the replacement of major fixed assets.
- 74. Allow the Mine Safety and Training Section to restore Building #25 at the Stewart Facility in Carson City for use as a training and testing facility, using donated equipment and materials. Consider utilizing other buildings at the site for similar purposes.
- 75. Consider elimination of the State Motor Pool in urban areas in favor of using contracts with car rental agencies.

HUMAN RESOURCES CONCEPTS

- 76. Privatize all adoptions for faster and better service to the client/parent.
- 77. Review the social services eligibility process, e.g., one-stop shop and single applications in lieu of multiple locations of contact and associated applications.
- 78. Consider limiting caseworker access to only scheduled appointments to avoid case processing time being diverted by drop-in claimants.
- 79. Is it mandatory for the state to maintain a "one-size-fits-all" application of human resource services, or is there flexibility to allow local service areas with specific problems to "pick and choose" the services to be received, e.g., Washoe and Clark counties may require the "full range" of services, whereas a small rural area may only need selected services.
- 80. Improve ability of administrators of contracts with providers of care to the developmentally disabled to withhold payments when contractors fail to report periodically on aspects of treatment plans that may affect human rights of clients.
- 81. Consider repeal of A.B. 280 (1999 Session), which amended intervention procedures for the disabled, to ensure that new requirements do not inadvertently cause harm clients when staff might hesitate to initiate beneficial emergency procedures for fear of violating provisions of the bills that require cumbersome reports and paperwork.
- 82. Consider consolidation of certain Division of Child and Family Services functions at either the state or county government level. (See recommendations of the Interim Legislative Study on Long-term Care and any recommendation from the State-Local Government Subcommittee.)
- 83. Evaluate consolidation of long-term care fiscal and administrative responsibilities at either the state or county government level. (See recommendations of the Interim Legislative Study on Long-term Care and any recommendation from the State-Local Government Subcommittee.) (See also SCR 4 BDR 300 and McGinness BDR 313.)
- 84. Authorize a study, for recommendation to the 2003 Legislature, the consolidation of all health education and

prevention programs and all substance abuse, drug education, and prevention programs to the Health Division.

- 85. Consider consolidation of the Supplemental Fund for Medical Assistance to Indigents and the Indigent Accident Fund, which are currently the responsibility of the Department of Administration, with the Fund for the Institutional Care of Medical Indigents that is the responsibility of the Division of Health Care Financing and Policy (Budget Accounts 3244, 3245, 3246); then consolidate all into the Division of Health Care Financing and Policy (Budget Account 3158) using specific categories for each.
- 86. Evaluate the consolidation of all homeless assistance grant functions with the Office of Community Connections.
- 87. Establish clear and uniform procedures for the regulation of child care facilities through the Department of Human Resources. (See Leslie BDR 1.)
- 88. Consider the transfer of the Individual and Family Grant Program from the Welfare Division to the Division of Emergency Management.

PERSONNEL CONCEPTS

- 89. Modify the current frozen merit concept used in the budget process to reduce the fiscal impact on the small agency, e.g., use the same threshold as vacancy savings and allow for flexibility for those accounts with a high percentage of frozen merit positions.
- 90. Establish uniform standards for the workplace, e.g., job performance, smoking, sexual harassment, etc.
- 91. Eliminate the calculation of vacancy savings for non-SGF agencies.
- 92. Consider authorizing employees eligible for retirement to receive full payment for all accumulated sick and vacation leave in the form of either the purchase of additional retirement credits, the funding of future medical insurance premiums, or a combination thereof. (See Legislator BDR 210.)
- 93. Consider allowing public safety employees to receive pay for holidays either as compensatory time off or as pay.
- 94. Allow Department of Personnel to establish a uniform policy for professional positions to receive overtime benefits. (See Personnel BDR 532 and Parnell BDR 438.)
- 95. Consider applying the revenue in excess of projections to fund state agency technology improvements and provide additional employee training. (See #21 on Primary Recommendation list.)
- 96. Consider changing the Public Employees Retirement System to a defined contribution plan for future hires.
- 97. Evaluate benefits of providing incentives, through the establishment of a "cost savings" program, for state employees to receive additional training or allow department equipment to be upgraded.

PUBLIC SAFETY AND PRISONS CONCEPTS

- 98. Evaluate the benefit of assessing inmates a utility charge for electrical appliances, similar to Arizona's program.
- 99. Evaluate the benefits of the Youth Corrections Challenge Grant program.
- 100. Standardize radio specifications (800 MHz vs. High Band, etc.).

- 101. Establish a Bureau/Division of Investigations for all investigators, detectives, agents to mirror states comparable with Nevada.
- 102. Evaluate the benefit of the Office of the Military being in the social services business, e.g., Project Challenge.
- 103. Consider transferring the Division of Emergency Management to the Office of the Military or Office of the Governor.

TAXATION AND FEES CONCEPTS

- 104. Maximize user fee revenues, thus reducing the need for the general taxpayer to support state government.
- 105. Consider removing state agencies' statutory authority to adopt fees, and replace with fee adoption by regulatory authority.
- 106. Evaluate the current method of allocating administrative court assessment fees.
- 107. Investigate how the real estate transfer tax, which was recently transferred from the federal government to the states, is being collected and used in Nevada. (Suggested uses children, schools, housing programs, and so forth.)
- 108. Investigate how the state can obtain more advanced information on revenue from the estate tax.

CONSTITUTIONAL OFFICE CONCEPTS

- 109. Inventory all outside bank accounts to determine if they were established according to statute and whether they are still appropriate.
- 110. Evaluate the cost benefits of the use of variable interest rates by the Treasurer.
- 111. Aggressively pursue accounts receivable collections to reduce bad debts and increase available resources.
- 112. Consider a constitutional amendment to either consolidate the Office of the Controller with the Office of the Treasurer or consolidate the Office of the Controller with an expanded Department of Administration and Finance.
