* 1	S.J.R. 3 of the 68 th Legislative Session	Proposes to amend <i>Nevada Constitution</i> to limit length of legislative session and to require submittal of proposed executive budget to Legislature before commencement of legislative session.
* 2	S.J.R. 14 of the 68 th Legislative Session	Proposes to amend <i>Nevada Constitution</i> to authorize Legislature to provide for abatement of taxes on property used in manner that conserves water.
* 3	A.J.R. 13 of the 68 th Legislative Session	Proposes to amend <i>Nevada Constitution</i> to provide for resolution of conflicts between certain amendments of statutes and constitutional provisions.
