Re: 2012 Regional Plan Environmental Analysis, Threshold Standards, and Other
Environmental Updates and/or Revisions

Dear Governing Board Members:

During the course of the Legislative Committee for the Review and Oversight of the Tahoe Regional Planning Agency (TRPA) and the Marlette Lake Water System (MLWS) for the 2023–2024 Legislative Interim, the Committee received testimony by the public at several meetings and input from other stakeholders that indicated the need for updates regarding the status of various environmental standards utilized by the TRPA.

At the final meeting and work session of the Legislative Committee for the Review and Oversight of the TRPA and the MLWS held on August 16, 2024, the Committee voted unanimously to send a letter to the TRPA requesting that, prior to the start of the 2025 Legislative Session, the Agency provide the Committee with the status of its update to the environmental analysis conducted in the 2012 Regional Plan, any updates and any planned or in progress revisions to the TRPA's Threshold Standards, and any other environmental standard updates/revisions.

It will be helpful to the Committee Members if TRPA's response includes an executive summary of any technical data contained in its response. The TRPA should be prepared to provide a presentation regarding this request to the Legislative Committee for the Review and Oversight of the TRPA and the MLWS during the 2025–2026 Interim.


