V. Discussion of Proposed Bill Draft Requests (BDR) Selected at the October 22, 2024, Meeting of the NYL

A. BDR 3—This bill would require staff members of a school to report to the administrator of the school a pupil exhibiting behavior consistent with drug or tobacco use and require: (1) the administrator notify the parent or guardian of the pupil and schedule a meeting with the parent or guardian; (2) a report be filed with the school; (3) resources given to the family; and (4) a follow up meeting with the pupil. A report to law enforcement may be done if deemed necessary. Reports will also be made available to the Legislature with the pupil's personal information redacted.

B. BDR 6—Existing law authorizes a parent or guardian to be held civilly liable when his or her child uses a firearm if: (1) the parent or guardian authorized the child to use or possess the firearm; (2) the child used the firearm in a negligent manner or for willful misconduct; and (3) the minor has been previously adjudicated or convicted, has a propensity for violence, or knows the minor intends to use the firearm for unlawful purpose. This bill would remove the requirement that the parent or guardian had any knowledge of potential misuse of the firearm, thereby authorizing a parent or guardian to be civilly liable whenever a child uses a parent’s firearm negligently or for willful misconduct. This bill would also make a violation of this law a category B felony punishable by 1–20 years in prison.
