**DISCIPLINARY ACTION, FOURTH QUARTER 2005:**

**CASE NUMBER:** 20050517  
**DATE RECEIVED:** 05/06/05  
**RESPONDENT:** Omar Hindiyeh, Non-licensee  
**COMPLAINANT:** Internal  
**ALLEGATION/S:** Alleged violation of NRS 625.  
**SUMMARY:** Offering engineering services in Nevada without a license.

**STATUS:** Issued a stipulated agreement that: 1) he will cause his employer, CMA Consulting, to immediately cease and desist from practicing, offering to practice or attempting to practice professional engineering in the State of Nevada without having a Nevada licensed professional engineer in its full-time employ; 2) to cause his employer to remove all references to the practice of engineering from its contracts, title blocks on plans, website, stationery and business cards and all telephone directory listings, unless and until CMA Consulting has in its employ a professional engineer licensed to practice in the discipline to be performed at each place of business in the State of Nevada; 3) Within thirty (30) days forward to the Executive Director of the State Board copies of the revised contracts, title blocks, stationary and business cards of CMA Consulting which show the references to professional engineering have been deleted; 4) Within 30 days forward copies of all correspondence to various telephone companies requesting removal of all advertisements and listings which indicate CMA Consulting is authorized to perform engineering services in Nevada; 5) the above restrictions shall remain in place until CMA Consulting has employed a full-time professional engineer in Nevada.

**ALLEGATION/S:** Alleged violation of NRS 625.  
**SUMMARY:** Alleged incompetence in preparing plans for a sewer.

**STATUS:** Accepted a stipulation agreement to: be issued a public reprimand; pay \$1,100 to Mr. & Mrs. Parham within (10) days and submit proof of payment to the Executive Director of the State Board; shall reimburse the State Board for its investigative costs and fees in the amount of \$1,000 within 30 days; submit copies of all contracts and proposals executed in his capacity as a professional engineer to the State Board for a period of one year; within one year successfully complete the Texas Tech Professional Ethics Correspondence course; and within one year successfully complete an ABET approved university level course concerning the preparation of professional engineering contracts.

**COMPLAINANT:** Internal  
**ALLEGATION/S:** Alleged violation of NRS 625.  
**SUMMARY:** Violation of 1995 stipulated agreement by performing engineering services outside his area of expertise; stamped, signed and submitted plans to a public agency using the stamp and signature of another engineer without his knowledge or permission.

**STATUS:** Issued a Decision and Order to suspend his license to practice engineering in the State of Nevada for one year commencing November 18, 2005; during suspension, he shall not personally contract with or offer to perform engineering services for a third party; after suspension has been served, he is placed on probation for two years; shall refrain from practicing civil engineering in the area of structures; shall submit quarterly reports setting for the nature and scope of the work performed during suspension and probation; assessed an administrative fine of \$5,000; and ordered to pay investigative costs in the amount of \$1,715.
