Section 1. NAC 449.013 is hereby amended to read as follows:

449.013 1. Except as otherwise provided in NAC 449.0168, an applicant for a license to operate any of the following medical facilities or programs of hospice care must pay to the health division the following nonrefundable fees:

(a) An ambulatory surgical center	\$1,200
(b) A facility for the treatment of irreversible renal disease	1,200
(c) A home office or subunit agency of a home health agency	1,200
(d) A branch office of a home health agency	500
(e) A rural clinic	1,200
(f) An obstetric center	1,200
(g) A program of hospice care	1,200
(h) An independent center for emergency medical care	1,200
(i) A nursing pool	750
(j) A facility for treatment with narcotics	750
(k) A medication unit	500

2. An applicant for the renewal of such a license must pay to the health division the following nonrefundable fees:

(a) An ambulatory surgical center\$600
(b) A facility for the treatment of irreversible renal disease
(c) A home office or subunit agency of a home health agency600
(d) A branch office of a home health agency
(e) A rural clinic
(f) An obstetric center
(g) A program of hospice care600
(h) An independent center for emergency medical care600
(i) A nursing pool600
(j) A facility for treatment with narcotics600
(k) A medication unit

3. An application for a license is [only] valid for [the calendar year in] *1 year after the date on* which the application is submitted. If an applicant does not meet the requirements for licensure imposed by chapter 449 of NRS or the regulations adopted pursuant thereto [on or before December 31 of the year in] *within 1 year after the date on* which he submits his application, he must submit a new application and pay the required fee to be considered for licensure.

Sec. 2. NAC 449.016 is hereby amended to read as follows:

449.016 1. Except as otherwise provided in NAC 449.0168, an applicant for a license to operate any of the following medical facilities or facilities for the dependent must pay to the

health division a nonrefundable fee of \$50 for each bed in the facility and the following nonrefundable fees:

(a) A skilled nursing facility\$1,200
(b) A hospital
(c) An intermediate care facility for the mentally retarded or persons with
developmental disabilities
(d) An intermediate care facility, other than an intermediate care facility for
the mentally retarded or persons with developmental disabilities
(e) A residential facility for groups
(f) A facility for the treatment of abuse of alcohol or drugs
(g) A freestanding facility for hospice care
2. An applicant for the renewal of such a license must pay to the health division a
nonrefundable fee of \$35 for each bed in the facility and the following nonrefundable fees:
(a) A skilled nursing facility\$1,100
(b) A hospital
(c) A rural hospital
(d) An intermediate care facility for the mentally retarded or persons with
developmental disabilities
(e) An intermediate care facility, other than an intermediate care facility for
the mentally retarded or persons with developmental disabilities
(f) A residential facility for groups
(g) A facility for the treatment of abuse of alcohol or drugs
(h) A freestanding facility for hospice care

3. An application for a license is [only] valid for [the calendar year in] *1 year after the date on* which the application is submitted. If an applicant does not meet the requirements for licensure imposed by chapter 449 of NRS or the regulations adopted pursuant thereto [on or before December 31 of the year in] *within 1 year after the date on* which he submits his application, he must submit a new application and pay the required fee to be considered for licensure.
