Notice of Hearing for the Adoption/Amendment of Regulations of the Private Investigator's Licensing Board

The Private Investigator's Licensing Board will hold a public hearing at 9 a.m. or as soon thereafter as possible, on December 11 and/or 12th, 2001, at the Grant Sawyer State Office Building, Legislative Council Bureau, 555 E. Washington Ave., Rm, 4400, Las Vegas, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations that pertain to chapter 648 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

The purpose is to have clarity to NAC chapter 648 as it pertains to the exemption of non-restricted license holders and/or their employees being licensed as private investigators under Nevada Revised Statute 648.018(4).

There will be no economic impact on the Private Investigator's Licensing Board. There will be no economic impact on the public in the State of Nevada.

There will be no increase in cost to the Private Investigator's Licensing Board to enforce the proposed amended regulation.

There is no duplication or overlaps of any federal state or local governmental agencies.

There is no fee assessment with this proposed amendment regulation.

PROPOSED REGULATION OF THE PRIVATE INVESTIGATOR'S LICENSING BOARD

Authority: NRS chapter 648.030

"Chapter 648 of NAC is hereby amended by adding thereto a new section to read as follows:

Section 1. A holder of a non-restricted license issued pursuant to NRS 463.0177(2) shall not be considered a private investigator as defined in NRS chapter 648 or subject to regulation thereof if such a licensee:

- a. Employs an individual who acts as a customer or client of a licensee for the purpose of evaluating the service provided to customers or clients by the employees of the licensee;
- b. Employs an individual who acts as a customer or client of a licensee for the purpose of evaluating the operational procedures and cleanliness of the property and the quality, availability and prices of the goods and services of the licensee;
- c. Employs a Nevada business or agency fort the purpose of evaluating, without limitation, operational procedures, methods of prevention, and study for problems of underage gambling, and problems of underage drinking."
