PROPOSED REGULATION OF THE DEPARTMENT OF MOTOR VEHICLES

October 1, 2001

Proposed NAC related to Senate Bill 35, of the 1999 Legislative Session, that adds a section to Chapter 426 of the Nevada Revised Statutes.

Provisions regarding issuance of an Expedited Service Permit.

EXPLANATION - Matter in *italics* is new; matter in brackets H is material to be omitted.

AUTHORITY: NRS 426.401 - 426.451

- Sec. 1. Chapter 426 of NAC is hereby amended by adding thereto the provisions set forth as sections 2 through 4, inclusive of this regulation.
- Sec. 2. 1. For the purpose of enforcing the provisions of Section 2 through 4, inclusive of this regulation, "department" means the department of motor vehicles.
 - 2. Person with a permanent disability has the same meaning as defined in NRS 482.3835 and 426.431.
 - a. NRS 482.3835 "Person with a disability which limits or impairs the ability to walk" defined. As used in NRS 482.384, unless the context otherwise requires, "person with a disability which limits or impairs the ability to walk" means a person who:
 - 1. Cannot walk 200 feet without stopping to rest;
 - 2. Cannot walk without the use of a brace, cane, crutch, wheelchair or prosthetic or other assistive devise, or another person;

- 3. Is restricted by a lung disease to such an extent that the person's forced expiratory volume for 1 second, when measured by a spirometer, is less than 1 liter, or the arterial oxygen tension is less than 60 millimeters of mercury on room air while the person is at rest;
- 4. Uses portable oxygen;
- 5. Has a cardiac condition to the extent that the person's functional limitations are classified in severity as a Class III or Class IV according to standards adopted by the American Heart Association;
- 6. Is visually handicapped; or
- 7. Is severely limited in his ability to walk because of an arthritic, neurological or orthopedic condition.
- b. NRS 426.431 "Person with a permanent disability" means a person:
 - 1. With a disability which limits or impairs the ability to walk, as defined in NRS 482.3835, and
 - 2. Whose disability has been certified by a licensed physician as irreversible.
- Sec. 3. 1. The department shall, not less than 60 days before the date on which the Expedited

 Service Permit expires mail a renewal notice to the permit holder.
 - a. The notice shall include an application which must be completed by the applicant and a licensed physician.
 - 2. A permit holder may renew the Expedited Service Permit by mail every other renewal cycle.

- a. The department will notify the permit holder if they are eligible to renew by mail.
- Sec. 4 1. If an Expedited Service Permit is lost, stolen or destroyed, the permit holder must apply for a duplicate, in person, to the department.

Sec. 5 1. Fees;

- a. Original, duplicate or renewal issued to a person 65 years of age or older,\$4.00.
- b. Original, duplicate or renewal issued to a person under 18 years of age,\$3.00.
- c. Original, duplicate or renewal issued to any other person,\$9.00.
- d. A new photograph or change of name, or both, \$4.00.
- e. Photo Fee \$2.25
- 2. All money collected by the department pursuant to this chapter must be deposited in the state treasury for credit to the motor vehicle fund.
