Notice of Hearing for the Amendment of Regulations of the Department of Business and Industry, Office of Business Finance and Planning

The Department of Business and Industry, Office of Business Finance and Planning, 788 Fairview, Suite 100, Carson City, Nevada 89701, 775-687-4246, will hold a public hearing at 9:00 a.m., on Wednesday, July 12, 2006, via videoconference in the Hearing Room, 788 Fairview, Carson City, Nevada 89701 and in the Conference Room, 2501 East Sahara Avenue, Manufactured Housing Division, Suite 204, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations that pertain to chapter 348A of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment.

The amendments being proposed will accomplish the following:

(A) Allow the Director of the Department of Business and Industry ("Director") to better account for and avoid the abandonment of volume cap used by local governments and local agencies by requiring local governments and local agencies to file a report with the Director on the amount, sources and uses of volume cap for the current and immediately preceding three years;

Local governments and local agencies will have additional, although minor, requirements for the allocation and use of state volume cap in the immediate and long-term which should not involve any additional expense. Local governments and other persons who benefit from the use of state volume cap, including the public, will benefit in the immediate and long-term from provisions that will provide greater assurance that volume cap authority is not wasted.

PROPOSED REGULATION OF THE DIRECTOR OF THE DEPARTMENT OF BUSINESS AND INDUSTRY

Issuance of Private Activity Bonds

Explanation--Matter in *italics* is new, matter in brackets \longrightarrow is material to be omitted.

Purpose: To clarify procedures for allocation of state volume cap.

Authority: NRS 348A.040

Section 1. Chapter 348A of NAC 348A.180 is hereby amended by adding thereto a new section to read as follows:

- 1. Any local government or local agency which, on December 31 of any year, has indicated its intent, though adoption of a resolution or otherwise that it has used, or intends to use or has reserved its entire allocation of volume cap, or a portion thereof, for a specified project or use for that year, or has carried forward volume cap in any of the immediately preceding three years shall, on or before February 15, file a report with the Office of Business Finance and Planning that contains information regarding the amount of volume cap and the projects and uses of that volume cap for those years.
 - 2. The report required by subsection 1 must contain the following information:
- (a) The amount and source of volume cap used during that year for each project and authorized use;
- (b) The amount and authorized use of volume cap carried forward from that year to the subsequent year;
- (c) The amount of volume cap carried forward from each of the immediately preceding three years and available during that year, including the amount used, carried forward to the subsequent year, or abandoned during that year and the name of the project or authorized use to which the volume cap relates.
- 3. The Director will consider whether a local government or local agency has abandoned any volume cap in determining whether to consent to any transfers or augmentation of volume cap allocations pursuant to pursuant to NAC 348A.170 and 348A.180 or approve the transfer of volume cap pursuant to NAC 348A.230.
