NOTICE OF ADOPTION OF TEMPORARY REGULATION LCB File No. T036-09

The State Environmental Commission adopted temporary regulations assigned LCB File No. T036-09 which pertain to chapter 445B of the Nevada Administrative Code.

INFORMATIONAL STATEMENT

Temporary Regulation T036-09: With this temporary regulations the State Environmental Commission (SEC) is updating NAC 445B.221, "Adoption by reference and applicability of certain provisions of federal law and regulations." The SEC is adopting into state regulation sections of the Federal New Source Performance Standards (NSPS) and National Emission Standards for Hazardous Air Pollutants (NESHAP) rules that have been adopted by the U.S. Environmental Protection Agency (EPA) and published in the Federal Register since the NAC was last updated, as well as certain test methods.

This temporary regulation is necessary so that Nevada can request delegation for the implementation of new and revised federal NSPS and NESHAP rules that became effective after March 2008. This update will allow the regulated industry to continue to work with the state as opposed to US EPA. Additionally, adopting the test methods will allow the Nevada Division of Environmental Protection to use methods approved by US EPA and recognized by the scientific community to measure emissions from sources.

The Nevada Division of Environmental Protection, Bureau of Air Quality Planning held a public workshops on the above referenced regulation on May 28, 2009 in Carson City at the Bryan building (901 South Stewart Street).

Following this workshop, the State Environmental Commission (SEC) held a public hearing to consider the regulation on June 17, 2009. The hearing was held at the Nevada Department of Wildlife's Conference Room A, 1100 Valley Road, Reno, Nevada. The SEC hearing agenda was posted at the meeting location, at the State Library in Carson City, and at the Offices of the Division of Environmental Protection in Carson City and Las Vegas. Copies of the agenda, the public notice, and the proposed regulation were also made available to all public libraries throughout the state as well as to individuals on the SEC electronic and ground-based mailing lists.

The public notice for the regulation was published on Monday June 1, June 8th and June 15th in the Las Vegas Review Journal and Reno Gazette Journal newspapers.
