

# **PROPOSED REGULATION OF THE BOARD OF MEDICAL EXAMINERS**

## **LCB File No. R062-11**

### **Notice of Workshops to Solicit Comments on Proposed Regulations**

The Nevada State Board of Medical Examiners, located at 1105 Terminal Way, Ste. 301, Reno, Nevada 89502, (775) 688-2559 is proposing the amendment of regulations pertaining to chapter 630 of the Nevada Administrative Code. A workshop has been set for 11:00 a.m., on Wednesday, December 7, 2011, at 1105 Terminal Way, Ste. 301, Reno, Nevada. The workshops will be videoconferenced to the conference room at the Nevada State Board of Medical Examiners/Dental Examiners located at 6010 S. Rainbow Blvd., Bldg. A, Ste. 1, Las Vegas, Nevada. The purpose of the workshops is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

R043-11      1)      Relating to practitioners of respiratory care; revising provisions relating to proof the applicant for licensure is required to submit to the Board of Medical Examiners concerning the completion of an educational program as a practitioner of respiratory care; and providing other matters properly relating thereto.

R059-11      2)      Relating to standards for the provision of health care; updating the title of certain guidelines for pain control adopted by the Board of Medical Examiners; and providing other matters properly relating thereto.

R060-11      3)      Relating to providers of health care; revising provisions governing investigations concerning practitioners of respiratory care and perfusionists who test positive for exposure to human immunodeficiency virus; and providing other matters properly relating thereto.

R061-11      4)      Relating to perfusion; requiring an original signature on a document submitted to the Board of Medical Examiners by an applicant for a license to practice as a perfusionist; and providing other matters properly relating thereto.

R062-11      5)      Relating to disciplinary findings and orders; providing for the delivery of certain disciplinary findings and orders of the Board of Medical Examiners by electronic mail to hospitals and members of the media; revising provisions governing the delivery of disciplinary findings and orders of the Board to include findings and orders pertaining to perfusionists and practitioners of respiratory care; and providing other matters properly relating thereto.

**NOTICE OF INTENT TO ACT UPON REGULATIONS**  
**Notice of Hearings for the Adoption/Amendment of Regulations of the**  
**Nevada State Board of Medical Examiners**

The Nevada State Board of Medical Examiners will hold public hearings at 11:00 am, on Wednesday, December 21, 2011, at the office of the Nevada State Board of Medical Examiners located at 1105 Terminal Way, Ste. 301, Reno, Nevada. The public hearings will be videoconferenced to the conference room at the Nevada State Board of Medical Examiners/Dental Examiners located at 6010 S. Rainbow Blvd., Bldg. A, Ste. 1, Las Vegas, Nevada. The purpose of the hearings is to receive comments from all interested persons regarding the adoption of regulations that pertain to chapter 630 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The proposed amendments are necessary to establish Board of Medical Examiners policy and to clarify existing Board of Medical Examiners policy.
2. A copy of this notice and the regulations to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulations to be adopted will be available at the office of the Nevada State Board of Medical Examiners at 1105 Terminal Way, Ste. 301, Reno, Nevada 89502, and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. 3. The proposed amendment will not have a direct economic effect on the business of the practice of medicine or the public.
4. Enforcement of the proposed amendments will not result in an increased cost to the Nevada State Board of Medical Examiners.
5. To the Board's knowledge, the proposed amendments do not overlap or duplicate the regulations of other state or local governmental agencies or any federal regulations.
6. The proposed regulations do not establish new fees or increase existing fees.

Persons wishing to comment upon the proposed action of the Nevada State Board of Medical Examiners may appear at the scheduled public hearing or may address their comments, data, views, or arguments, in written form, to the Nevada State Board of Medical Examiners, P.O. Box 7238, Reno, Nevada 89510-7238. Written submissions must be received by the Nevada State Board of Medical Examiners on or before

**January 6, 2012.** If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Board of Medical Examiners may proceed immediately to act upon any written submissions.
