Notice of Hearing for the Amendment of Regulations of the Nevada Department of Agriculture

The Nevada Department of Agriculture will hold a public hearing 2 pm., on December 5, 2011, at Agriculture Headquarters, 405 South 21st Street, Sparks, NV 89431; Phone: (775) 353-3601. The purpose of the hearing is to receive comments from all interested persons regarding the Amendment of regulations that pertain to chapter 555 of the Nevada Administrative Code.

The purpose is to solicit public comments from interested persons on the following proposed regulation:

LCB File No. R092-11: A REGULATION relating to agriculture; increasing fees for licensing of dealers of nursery stock; deleting a provision requiring under certain circumstances the Director of the State Department of Agriculture to charge one-half of the annual fee otherwise required for licensing dealers of nursery stock; and providing other matters properly relating thereto.

Workshops were held and comments solicited to determine an estimate of the impacts on small business owners.

The fees will increase the cost to businesses, but will not cause an active business to go out of business. NRS 555.236 has a hardship provision to prevent this. There is no adverse effect on the public.

Businesses will benefit from the continued service of full time inspection staff. The public will benefit because the frequency in which nursery stock being offered for sale to the public is inspected for plant pests that have detrimental economic or environment effects can continue at its present level.

There will be no additional cost to the Nevada Department of Agriculture for enforcement of the proposed regulation.

The proposed regulation will not overlap or duplicate any regulations set by federal, state or local governmental agencies.

The proposed regulation is not required by federal law.

The proposed regulation does not include any provisions more stringent than a federal regulation that regulates the same activity.

The proposed regulation increases an existing fee.
