## WAYS AND MEANS COMMITTEE

## NEVADA STATE LEGISLATURE, 54TH SESSION, 1967

Meeting was called to order by Chairman Norman Glaser at 8:42 A.M. March 15, 1967 in Ways and Means Committee Room.

Present: Young, Harris, Glaser, Bowler, Tyson, Jacobsen, Howard, Mello, Ashworth

Absent: None

Also present - Press; Bob Bruce, Howard Barrett

Chairman Glaser announced Page 158, State Library, Title III, would be under discussion as budgets were finalized. All federal funds.

Mrs. Tyson moved "do pass per governor's recommendation." Seconded by Mr. Jacobsen. Motion carried.

Title IVB - Library Services to the Physically Handicapped -- discussion.

<u>Title IVB</u> - Librarian asking that Legislature give her authorization to receive federal money if she can match it with non-general fund money. Mr. Young moved to approve IVB, "do pass." Seconded by Tyson. Motion carried.

Title IVA - Recommending general fund money recommended be authorized to spend \$44,000 in federal monies.

Mr. Howard moved that the Librarian (State) can match federal funds-under Title IV A-with General Fund money. Seconded by Tyson. Motion carried.

Page 159. Harris moved that we include \$2600 for the four wheel drive. Seconded by Mr. Jacobsen. Motion carried.

Moved and seconded that Committee approve budget as amended. Motion carried.

Nevada Historical Society, Page 161. Young moved, approve as governor recommended. Seconded by Ashworth. Motion carried.

<u>Page 163</u> - Funds will revert if not approved. Howard moved "do pass and approve." Seconded by Bowler. Motion carried.

Lost City Museum. Ashworth moved, approve Governor's recommendations. Seconded by Harris. Motion carried.

Page 165 - Nevada Heritage Association. \$1.00. Jacobsen moved "do pass." Howard seconded. Motion carried.

Chairman Glaser said he had an amendment to resolve the conflict on  $\underline{AB~344}$  by deleting lines 6 through 9, etc. Young moved bill be indefinitely postponed. Seconded by Tyson. Morion carried.

Mr. Bowler left at 8:55.

Discussion of AB 344 - Committee felt Archives butting into the Historical Society. Asked Howard Barrett what he thought. He said he'd rather stay out of it.

Mr. Howard asked to meet with meat packers at 2P.M. this day.

Chairman Glaser said said they were going to meet with the Taxation Committee at 7:00 P.M. this day, as the Committee is now beginning to get the picturemoneywise and know between 5 and 6 million dollars will be needed - depending on Welfare needs.

Mr. Harris said he would like to meet with the meat packers. Mr. Howard said he was going. Mr. Harris said he would write something out for Mr. Howard to take. Mr. Ashworth said the Committee could report on Tax Committee this afternoon. Meeting adjourned at 9:00 A.M. until 2:00 P.M. this afternoon.
