MINUTES OF THE MEETING - WAYS AND MEANS COMMITTEE - REVADA STATE LEGISLATUREZ6
FIFTY FOURTH SESSION

Meeting was called to order by Chairman Norman Glaser at 2:10 PM, March 15, 1967 in the Ways and Means Committee Room.

Each member of the committee received from Mr. Bruce copies of letters dated March 9, 1967 pertaining to Aid to Dependent Children and Foster Care programs, Staffing Recommendations to quality for federal aid, a copy of a letter dated March 10, 1967 regarding Mentally Retarded Cottages, and one dated March 15, 1967 regarding additional welfare positions. (Attach to and make part of the minutes.)

Makes supplemental appropriation for welfare division for old-age assistance and medical assistance for the aged; authorizes, transfers of portion of money previously appropriated for certain types of public assistance for old age assistance and medical assistance for the aged.

Mr. Glaser stated this was virtually the same bill as \underline{AB} 400 in the Assembly on the Board. Recommended that \underline{AB} 400 be pulled off the Board and they wait for \underline{SB} 388 to come to the Assembly for replacement. The Committee agreed that this be done.

Page 238 Child Welfare Services

Discussion by the Committee as to whether to add additional case workers to qualify for federal aid. Review of the letter dated March 15, 1967.

Mr. Young moved to accept the additional welfare positions.

Dear Floyd:

At the time the Budget was prepared, it was the belief of this office that the staffing recommendations met the federal requirements necessary to qualify for maximum federal contributions to our Welfare program. Subsequent discussions with the Welfare Division and federal administrators in San Francisco and Washington make it reasonably clear that the following additional positions are necessary to so qualify:

5 Social Work Supervisors

Federal regulations require a ratio of one supervisor for every five caseworkers. The original budget recommendations provided for such a ratio but on an average. It seemed reasonable that, in some cases, six or seven experienced caseworkers could be supervised by one supervisor. In other areas or work circumstances, one supervisor for four or even three workers might be reasonable. Meeting an average would allow some desired flexibility.

The federal government has taken a different position. It says that no supervisor can have more than five subordinate caseworkers. Since Nevada has eleven district offices with less than five workers, the rural districts have six supervisors for fourteen caseworkers. Just slightly above a two to one ratio. To maintain the one to five ratio in the Reno and Las Vegas area, three additional Social Work Supervisors are necessary.

In the original recommendation, two of the nineteen Social Work Supervisor positions were Social Work Supervisor III positions. These two positions do not supervise caseworkers. Therefore, to maintain the ratio of supervision, two more Social Work Supervisors are needed. The total additionally needed is five.

2 Social Service Specialists

In the original recommendation, two positions were deleted from this category. One was designated to carry out liaison with the State Hospital. Since the State Hospital has its own social work staff this seemed unnecessary. It still does. However, in order to earn approximately \$130,000 in Federal funds for the Hospital's contribution to the Medical Assistance to the Aged program, there must be this social service specialist. The second position is

a requirement to receive child welfare services funds from the federal government.

1 Staff Development Specialist

In order to qualify for 75% matching, the state must show improved quality of service. A staff development specialist can help in this regard. The federal minimum is "a full-time State training director and a full-time training director for each local agency having a substantial number of public assistance staff." Since Nevada has only two offices with more than five caseworkers, the Federal Government will apparently be satisfied with two training officers. With less than 100 caseworkers in the state, this office believed, and continues to believe, that one full-time training officer would be enough, but apparently the Federal Government is not willing to accept this.

1 Chief of Aging

This position is necessary to implement the Older Americans Act. This will mean some \$64,000 in Federal Funds for the State to carry out programs by community groups for the older people in our society. This position was initially not recommended in the belief that the need could be met by the existing position of Chief, Aged and Blind. This is apparently not possible because the Older American Act is financed through a different federal bureau and they want a person hired to specialize in working with programs for the aged.

The changes necessary in the printed budget to fund these additional positions are as follows:
