Minutes of Meeting Held
February 22, 1967

The eighth meeting of the Senate Committee on Federal, State, and Local Governments was called to order at 1:05 p.m., Wednesday, February 22, 1967, in Committee Room 50, State Capitol, by Chairman Gibson. All committee members were present.

The Chairman announced that beginning next week the committee would meet each day at 1:00 p.m., at least the first three days of the week.

He next called for consideration of next week's schedule. The following items were discussed:

S.B. 45: Provides for soil tests and regulation of construction in subdivisions. Introduced by Senator Herr.

Set up for consideration at 1:00 o'clock next Tuesday, February 28. Senator Farr will arrange to have a Sprout Engineers, Inc. (Sparks) representative at the meeting to discuss the bill, and Senator Gibson will ask Senator Herr and also a representative of Home Builders Association of Northern Nevada (Reno) to be present at the meeting.

SB. 104: Creates Nevada State Council of the Arts; defines council's powers and duties. Introduced by The Clark County Delegation.

Set for consideration Monday, February 27, 1:00 p.m.

S.B. 47: Provides for one member of California-Nevada Interstate Compact Commission actively interested in fish, wildlife, and recreation. Introduced by Senator Young.

Set for consideration Monday, February 27, 1:00 p.m.

S.B. 59: Prohibits commercial or industrial zoning of land within 400 yards of school sites. Introduced by Senator Young.

Set for consideration Tuesday, February 28, 1:00 p.m.

Bills -

S.B. 151: Prohibits State Contractors' Board from issuing licenses to gas, electric, or water utilities or their subsidiaries. (YOUNG)

-and-

S.B. 199: Prohibits public utility from installing, replacing or serving certain equipment beyond meter. (Young)

These two bills were scheduled for consideration Wednesday, March 1, at 1:00 p.m.

S.B. 170: Authorizes counties and cities to issue revenue bonds to finance industrial development. (Alleman)

Set for consideration Wednesday, March 1, 1:30 p.m. Fred Daykin of Legislative Counsel Bureau will be asked to appear, and the Chairman will ask Russ McDonald, Legislative Counsel, to contact Nick Smith of Smith & Burroughs, bonding attorneys, and ask Mr. Smith to appear.

S.B. 193: Authorizes political subdivisions to pay 100 percent of cost of premiums for public employees' group insurance and medical services. (Alleman)

Senator Hecht suggested the Chairman write to Art Trelease of Las Vegas re this bill.

S.B. 195: Provides for election of school trustees from certain cities. (Alleman)

Consideration of this bill will be scheduled later.


A.B. 50: Broadens authorized location of Division of Archives to Capitol, annex basements. (Introduced by Assembly Committee on State, County, and City Affairs.)

✓ Senator Farr moved "Do pass"; Senator Monroe seconded; motion passed unanimously.

A.B. 84: Provides for removal of city officers from office upon conviction of intoxication or use of drugs while in office. (Introduced by Mr. Kean)

✓ Senator Monroe moved "Do pass"; Senator Farr seconded; motion passed unanimously.
