SENATE COMMITTEE ON FEDERAL, STATE, AND LOCAL GOVERNMENTS

Minutes of Meeting Held March 22, 1967 8:00 a.m.

The 27th meeting of the Senate Committee on Federal, State, and Local Governments was called to order at 8:10 a.m. on Wednesday, March 22, 1967, in Room 50, State Capitol, by the Chairman, Senator James I. Gibson.

All committee members were present except Senator Farr, who joined the meeting at 3:35 a.m.

Also present:

Cy Ryan, Newsman (entered the meeting at 8:33 a.m.)

The Chairman announced the committee would conduct a hearing tomorrow at 1:00 p.m. on the 13-year-old voting bill (S.J.R. 11).

The following bills were then considered:

S.B. 170: Authorizes counties and cities to issue revenue bonds to finance industrial development. Introduced by Senator Alleman.

(At the committee's request, Mr. Frank Daykin of the Legislative Counsel Bureau entered the meeting at 8:20 a.m.)

Discussion.

DISPOSITION: Senator Hecht moved that the bill be amended on page 1, line 8, by inserting a comma after "industrial" and deleting "or" at the end of the line, and on line 5 by deleting "commercial and substituting therefor, "research and development". Senator Bunker seconded the motion.

Senator Monroe moved that the motion be amended to include the following: "In line 9, change the comma after 'enterprises' to a period and delete the rest of the line; delete all of line 20." The motion carried, with the following vote:

Aye - Senators Monroe, Bunker, Hecht, and Young No - None Not voting - Senators Alleman and Gibson Absent - Senator Farr

A vote was then taken on the original motion by Senator Hecht, and the motion carried, with the following vote:

Senator Alleman moved that the bill be reported out, "Amend and do pass as amended." Senator Monroe seconded the motion.

Mr. Cy Ryan and Senator Farr entered the meeting, at 8:33 and 8:35, respectively.

Senator Young moved the adoption of the amendments with respect to taxation (discussed at yesterday's meeting). The Chairman said these had been agreed upon for incorporation in the bill.

A vote was taken on Senator Alleman's motion, above, to amend and do pass as amended. The motion passed unanimously.

Mr. Daykin left the meeting (8:40 a.m.).

S.C.R.25: Directs study of balance of interests on boards and commissions in the state. Introduced by Senators Swobe and Bailey.

Comments by Senator Gibson. Senator Bailey entered the meeting (8:42 a.m.) at the request of the committee and commented on the bill. Discussion.

DISPOSITION: Senator Alleman moved, "Do pass." Senator Young seconded. The motion passed unanimously. (Senator Bailey left.)

S.C.R.27: Directs Legislative Commission to study laws on economic regulation of business and unfair competition. Introduced by Senator Brown.

Senator Alleman moved "Do pass." Discussion. At the request of the Chairman, Senator Brown joined the meeting (8:50 a.m.) and commented on the bill, then left at 8:57 a.m.

DISPOSITION: Senator Young moved "Do pass"; Senator Bunker seconded; the motion passed unanimously.

The Chairman stated he had talked with Russ McDonald about §.B. 420 (to permit establishment of town boards to govern unincorporated towns), and Mr. McDonald is apprehensive about this legislation; hence the Chairman said he would hold the bill up a couple of days.

The Chairman announced the next meeting of the committee would be at 1:00 o'clock this afternoon.

The meeting adjourned at 8:58 a.m.
