The 28th meeting of the Senate Committee on Federal, State, and Local Governments was called to order at 1:00 p.m. on Wednesday, March 22, 1967, in Room 50, State Capitol, by the Chairman, Senator James I. Gibson.

All committee members were present.

Also present: Mr. Cy Ryan, Newsman.

The Chairman called for consideration of the following bills:

- S.B. 462: Allows planning commission to adopt, amend master plan upon majority vote. Introduced by Senator Young.
 - DISPOSITION: Senator Young asked that the committee hold up consideration of the bill at this time.
- S.B. 466: Authorizes Colorado River Commission to quitclaim two minor parcels of land to National Lead Company. Introduced by Clark County Delegation.

Comments by Senator Gibson.

DISPOSITION: Senator Bunker moved, "Do pass"; Senator Young seconded; motion passed unanimously.

A.B. 54: Amends Water and Sewer Revenue Bond Law and clarifies and broadens powers concerning fixing, revising, and collection of service charges pertaining to water and sewer systems and the use of such charges. Introduced by Committee on State, County, and City Affairs.

Legislative Counsel Russ McDonald entered the meeting (1:23 p.m.) at the request of the Chairman, and commented on the bill, which he said had been introduced at his request. Discussion between Senator Gibson and Mr. McDonald.

DISPOSITION: Senator Young moved, "Do pass"; Senator Alleman seconded; motion passed unanimously.

Mr. McDonald left the meeting (1:35 p.m.).

A.B. 272: Removes Director of State Department of Conservation and Natural Resources as member of Colorado River Commission. Introduced by Mrs. Tyson.

DISPOSITION: Senator Farr moved, "Do pass, with the provision that those of us on this committee who serve in the next session give consideration to revision of the Colorado River Commission Act." Senator Bunker seconded the motion, and it passed with the following vote:

Aye - Senators Gibson, Alleman, Bunker, Farr, Hecht, and Young.

No - Senator Monroe
