SENATE COMMITTEE ON FEDERAL, STATE, AND LOCAL GOVERNMENTS

Minutes of Meeting Held April 11, 1967

The 39th meeting of the Senate Committee on Federal, State, and Local Governments was called to order by the undersigned, Chairman, on Tuesday, April 11, 1967, at approximately 8:00 a.m. in Committee Room 50, State Capitol.

All committee members were present.

The following bills were considered:

A.B. 282: Torvinen. Includes public automobile parking facilities in exemption from taxation of exempt real estate subject to taxation when leased to, used in business conducted for profit.

DISPOSITION. Amended to make it apply only to the existing situation in Reno. Senator Young moved, "Amend and do pass." Senator Monroe seconded. The motion passed with a vote of 5 to 2.

A.B. 149: Espinoza. Provides higher income standard for tenant preferences by housing authority.

DISPOSITION: Amended to write in amendment requested by North Las Vegas on servicemen's housing. Senator Farr moved, "Amend and do pass." Senator Alleman seconded. Motion passed unanimously.

A.B. 227: Hilbrecht, Frank Young, Bowler, Smith, Dungan, Brookman, Espinoza, Bishop, Bryan Hafen, and Close. Increases qualifications, provides for salaries of certain justices of the peace.

DISPOSITION: On recommendation of the Chairman, rereferred to the Clark County Delegation.

A.B. 243: Committee on State, County, and City Affairs. Provides general method for adoption of city ordinances and publication by title.

DISPOSITION: Senator Young moved that the bill be killed. Senator Hecht seconded. The motion passed with a vote of 7 to 0.

A.B. 304: Clark County Delegation. Provides for temporary appointment of county surveyor in certain counties.

DISPOSITION: Senator Young moved to kill the bill. Senator Alleman seconded the motion. It carried with a vote of 7 to 0.

A.B. 510: Committee on State, County, and City Affairs. Provides for air pollution control.

DISPOSITION: Senator Bunker moved, "Do pass." Senator Monroe seconded. The motion passed unanimously.

A.B. 406: Committee on State Institutions and Libraries. Eliminates inconsistencies in public library laws.

Frank Daykin of the Legislative Counsel Bureau came in and explained this bill to the committee.

DISPOSITION: Senator Farr moved, "Do pass." Senator Monroe seconded. Motion passed unanimously.

A.C.R. 13: Clark County Delegation. Authorizes acquisition by the State Park System of certain land in Clark County (Red Rock Park).

DISPOSITION: Senator Monroe moved, "Do pass." Senator Bunker seconded. Motion passed unanimously.
