

## NEVADA LEGISLATURE - 54TH SESSION

SENATE COMMITTEE ON  
FEDERAL, STATE, AND LOCAL GOVERNMENTSMinutes of Meeting Held  
April 5, 1967

The 37th meeting of the Senate Committee on Federal, State, and Local Governments was called to order at 1:00 p.m. on Wednesday, April 5, 1967, in Room 50, State Capitol, by the Chairman, Senator James I. Gibson.

All committee members were present except Senator Monroe, who joined the meeting at 1:20 p.m.

Also present: Mr. Russ McDonald

The Chairman called for consideration of:

A.B. 48: Clarifies requirements for publication of financial reports by local governments. Introduced by Committee on State, County, and City Affairs.

Mr. McDonald explained the background of the bill. In the discussion that followed, objection was expressed to the word "may" on page 2, line 5.

✓ DISPOSITION: Senator Hecht moved that the word "may" on line 5, page 2, be changed to "shall" and that the bill be reported out, "Amend and do pass." Senator Young seconded the motion. It passed unanimously. The Chairman stated there was a notice of conflict on this bill. He handed it to Russ McDonald to cure the conflict.

A.B. 144: Provides for election at large of hospital trustees in certain counties and places one county commissioner on hospital board in certain counties. Introduced by Washoe County Delegation.

The Chairman had the amendments to the bill which Senator Young had had prepared as discussed at the March 29 meeting (see page 3, minutes of 31st meeting).

✓ DISPOSITION: Senator Young moved, "Do pass as amended"; Senator Farr seconded; motion passed unanimously.

A.B. 282: Includes public automobile parking facilities in exemption from taxation of exempt real estate subject to taxation when leased to, used in business conducted for profit. Introduced by Mr. Torvinen.

Comments on background of bill by Mr. McDonald.

DISPOSITION: The Chairman will have Mr. Torvinen come in and talk to the committee about the bill.

A.B. 505: Makes technical corrections in Local Governments Securities Law. Introduced by Committee on State, County, and City Affairs.

Comments by Mr. McDonald.

✓ DISPOSITION: Senator Monroe moved, "Do pass." Senator Farr seconded. The motion passed unanimously.

A.B. 513: Changes boundary line between Douglas and Lyon Counties. Introduced by Committee on State, County, and City Affairs.

Comments by Mr. McDonald.

✓ DISPOSITION: Senator Alleman moved, "Do pass." Senator Bunker seconded. The motion passed unanimously.

S.B. 287: Amends North Las Vegas city charter to increase salaries of mayor and councilmen; requires publication of city's legal notices in newspaper published in city. Introduced by Senator Alleman.

The Chairman called on Senator Alleman, who commented on the bill. Mr. McDonald outlined the background of the bill. Senator Gibson read the amendments to the bill. These delete all references to pay raises, which are now provided for in a separate bill.

✓ DISPOSITION: Senator Farr moved, "Do pass"; Senator Monroe seconded; motion passed unanimously. The Chairman said this bill also contains a conflict, which he would have cured.

The meeting adjourned at 1:30 p.m.
