JUDICIARY COMMITTEEMINUTES OF MEETING HELD
FEBRUARY 21, 1967

A meeting of the Judiciary Committee was held at 9:05 A.M., Tuesday, February 21, 1967, in Committee Room 56, State Capitol, Chairman Monroe presiding.

Chairman Monroe stated that he had obtained a copy of the Arizona Preference Act. He mentioned that their law divided into separate sections, contractors for public works, local manufacturing, materials, and supplies. The members were provided with copies and will give it study before further consideration.

S.B. 68 "Provides for summary eviction or exclusion of certain tenants."

Senator Swobe stated that he wished to change the word "shall" to "may" on Page 1, Line 14.

Disposition: ON MOTION of Senator Dodge, seconded by Senator Bunker, it was unanimously agreed to "change the word "shall" to "may" on Page 1, Line 14, and Do Pass as Amended."

S.B. 53 "Requires uninsured motorist insurance provision in new automobile insurance policies."

Senator Young advised that he had received the proposed amendments and had given them to Mr. Pete Kelley for the insurance groups to study.

S.B. 71 "Specifies circumstances under which total number of directors of private corporation can be reduced to less than three."

Chairman Monroe asked Mr. Russ McDonald's presence for consultation. Mr. McDonald recommended passage of the Bill.

Disposition: ON MOTION of Senator Dodge, seconded by Senator Christensen, it was unanimously agreed to "Do Pass S.B. 71."

S.J.R. 8 "Proposes constitutional amendment to enable board of county commissioners to determine salaries of other county officers."

Disposition: It was unanimously agreed to hold S.J.R. 8 in abeyance.

S.B. 66 "Provides for issuance by county clerks of certificates of permission to perform marriages."

S.B. 60 was also discussed briefly in connection with this Bill. Senator Swobe commented that perhaps one way in which to determine whether a person was an actual "minister" would be to require a filing, in affidavit form, of income for the previous quarter and if over 25% was for the performance of marriages they would obviously be in the "marrying Sam" category. Senator Monroe suggested that perhaps preventing them from using the word "Chapel" would remove the inference that it was a religious ceremony. Senators Bunker and Christensen were concerned about the licensing procedure and were opposed to making it necessary to have a civil ceremony in addition to a religious ceremony.

Disposition: ON MOTION of Senator Young, seconded by Senator Dodge, it was unanimously agreed to "Do Pass S.B. 66."

S.B. 111 "Proposes additional qualifications for licensing of real estate brokers, salesman; provides city license reciprocity for brokers, salesmen."

Chairman Monroe commented that the real estate people are supporting passage of the Bill as it contains very mild increases in requirements. Senator Christensen commented that he objected to the "high school graduate" requirement. Senator Dodge pointed out that by being licensed by the State they would not be required to pay city business licenses.

Disposition: ON MOTION of Senator Dodge, seconded by Senator Bunker it was unanimously agreed to "Hold over S.B. 111."

S.B. 137 "Makes extensive changes in provisions relating to vital statistics."

Chairman Monroe is to invite Harry K. Brown and Mr. John Sullivan to appear before the committee.

Chairman Monroe announced that there would be a meeting of the Committee after adjournment Monday, February 27, 1967, to consider all the so-called "Police Bills."

Chairman Monroe also announced that there would be a Joint Meeting on March 1, 1967, to consider S.B. 140 and 168, and insurance representative would be present.

The meeting adjourned at 9:55 A.M.
