Richard Morgan of NEA spoke briefly for this measure.

Assemblyman Jack Schofield from Clark County said it would not be a financial problem with the amendments added and spoke in favor of this measure, due to personal experience and as a teacher.

Mr. Wilson asked him what grade he had taught and he answered the 5th. Mr. Wilson asked him if he had ever taught first and he answered no.

Mr. B. J. Berry, teacher Peavine School, told Committee he would be happy to answer any questions they would like to ask.

Mr. Smalley asked on what he based his support. What do you propose to do with these children who are above normal he asked. Mr. Berry answered keep him at home. They never have to be bored.

Chairman said there is talk about starting children earlier and earlier.

Mr. Wilson asked if they didn't think the teacher pupil ratio wouldn't help, smaller classes.

Miss Hawkins asked him what tells you the child is ready?

Mr. Berry answered one that can not work into a routine for one thing.

Bernice Ott spoke on the subject next and said that children needed this time at home as long a time as possible.

Emily Keating, teacher of 2nd grade, Carson City as well as mother of five children said she supported the bill from both standpoints. She added among her comments that all but two teachers in the shole system are supporting this bill.

Margaret Mason, teacher to the entire quota of elementary grades except first, was in favor of <u>SB 77</u>. Said that boys were slower than girls and this early school experience affected them more.

Betty Morris, Jessie Beck School in Reno showed samples (visual art displays) of younger children mixed in with those a few months older and compared them.

Dorothy Best said she had taught school twenty two years, fourteen years of which were in Nevada, also in Maryland and Virginia. She said here it is the most difficult as the other states have the six year old law.

Virginia Palmer, Reno 4th grade teacher, in favor of SB 77.

Roger Trounday of Carson City spoke in favor of this measure.

Ed Perry, principle of school in Lyon County recommended this measure.

Alice Wiggins, mother teacher favored the measure.

Robert Cahill, High School teacher spoke for this, as well as Heda Pennington of Reno and Marcella Rundis, kindergarten teacher from Las Vegas.

Chairman Swallow thanked all who spoke and said the Committee would give the measure careful consideration based on what they had heard on both sides in taking any action.
