Chairman Swallow convened the meeting at 10:30 A.M. for the purpose of further discussion and possible action on AB 393 at least as far as incorporating some of the amendments that had been suggested.

Chairman said that he thought he would appoint a sub-committee to do this and asked Miss Hawkins and Mrs. White if they would be on it and that he would work with them.

In discussion on what had transpired the day before Mr. Guinn said that he personally believed in accumulated sick leave.

It was brought out that one suggested amendment had been to change in Section 1, line 2 of AB 393 change teacher to employ so that it would cover everybody.

It was also mentioned to define family in section 7 and several instances where "may be" should be inserted rather than "shall be".

Miss Hawkins said that she would like to see AB 393 and AB 561 considered separately as they were contradictory in parts.

Miss Hawkins also said that no teacher gets paid for holidays as other employees do.

It was also mentioned that they could get disability, a factor that should be considered when considering long absences due to illness.

Mr. Smalley asked if there was a way to check when they were off if there was any checking to see if they were sick. He was told that it had been done occasionally but like all employees they took their word for it.

Chairman appointed Miss Hawkins, Mrs. White, Miss Foote and Mr. Smalley to check the possible ramifications of this with existing state laws and to go over the amendments and report back to the Committee.

Discussion was given to AB 609 for a brief period. A bill relating to dismissal of teachers.

Meeting adjourned at 11:30 A.M.
