Business before the committee was Proposed Changes in Chapter 293:

293.173: (a), (b) and (c) of Section 2; committee agreed to suggested changes; (d) will be held until information on voting machines is presented to the committee.

293.177: Committee agreed to suggested changes.

293.180: Committee agreed to change [Elector] to registered voter in one place and to person in two places.

293.205: Committee deleted first sentence. Dennis Wright will arrange the legal wording, and add; or even number years.

293.207: Change "voters" to registered voters in two places.

293.210: Committee agreed to suggested changes; change [Elector] to Registered voters in two places.

293.217: Committee deleted the suggested change.

293.253: Committee deleted the suggested change.

293.273: Committee agreed to suggested changes.

293.303: Committee agreed to suggested changes, but deleted paragraph on challenges.
