Chairman Smith stated that AB 49 referred to this committee was exactly the same as AB 63 referred to the Commerce Committee, with the exception of line 21, Section 2, and suggested that no action be considered on this measure until the Commerce Committee acted upon AB 63.

Chairman Smith thanked Assemblymen Lingenfelter and Getto for acting as chairman during the past week.

Assemblyman Branch asked that he not be listed as absent at the January 26, 1971, meeting as he was unable to attend the meeting because of committee business.

Chairman Smith ordered that the minutes be corrected to show that Assemblyman Branch was excused from the meeting.

Chairman Smith appointed the following sub-committees:

The Chairman explained that due to the large number of bills that will come before the committee the sub-committees would study and consider the bills which were assigned to them and report to the full committee their findings before any action is taken on a bill.

GOVERNMENT AFFAIRS COMMITTEE

COMMITTEE RULES - 56 SESSION

1. Five members constitute a quorum of the committee.
2. Motions will be moved, seconded and passed by a simple majority of those present, except that definite action ("Do Pass" or "Hold") on a bill will require a majority of the entire committee.
3. In order to reconsider previous actions taken, an affirmative vote of 6 members of the committee will be required.
4. Mason's Manual will be followed as to parliamentary procedure.
5. Any member of the committee may request an item on the agenda by contacting the chairman a day ahead of time.
6. Committee bill introduction will be by affirmative vote of 6 members present. Committee introduction does not imply in any way a commitment on the part of any committee member to support the bill.
