AB 178 - Extends amended provisions of Local Government Employee-Management Act to all government employees.

AB 178 was amended as follows:

All state employees removed from act.

Public Health Nurses are included.

Section 6 - retain old language defining strike.

Section 7 - remove new board.

Section 8 - remove completely.

Section 9 - Retain on line 22 or any party aggrieved.

Section 11 - make to conform with the removal of state employees.

Section 12 - lines 50 and lines 1 and 2 of page 5 amend to make the Director of the Department of Health, Welfare and Rehabilitation the bargaining agent for the State Health Nurses.

Section 2, Paragraph 2. line 4, leave new language in.

Section 13 - page 5, lines 21 and 22 - retain old language and strike out "in violation of law"

Page 6, lines 1, 2 and 3 retain new language.

Page 6 delete new section 3.

Page 6, lines 11 thru 20 adopt new language.

Page 6, lines 22 thru 28 strike out.

Page 6, lines 36 thru 49, on line 47 leave in "on or before December 1."

Section 16, page 7, paragraph 1 - leave in original language.

Section 16, page 7, paragraph 2, delete new language lines 20 and 21.
