Chairman Smith called the meeting to order.

AB 448 - Changes qualifications for Adjutant General.

General Edsall spoke against the bill saying that this change in qualifications would make the position too political, He suggested that the bill was too broad and perhaps a new bill could be drawn and presented next session which would be drafted in a better way. He objected to the change because he felt that it would take away the insentive for young officers in the Guard to work toward being Adjutant General. He also stated that he did not think an active duty officer would be able to understand the Guard program. Assemblyman Hawkins asked how wide the selection was presently. General Edsall replied that when he was selected that there were about 26 men qualified.

Chairman Smith commented that under the proposed change at least two members of the Assembly would be elegible to become Adjutant General.

Assemblyman Getto moved that AB 448 be Indefinitely Postponed. Assemblyman Lauri seconded the motion. The motion carried.

AB 461 - Changes Civil Defense and Disaster Agency to Nevada Disaster Office.

General Edsall explained that this had been done about a year ago by Executive Order and this was simply the legislation to make the order law. He explained that the two agencies work together closely now and in time of emergency they have plans to work together very closely. The General pointed out that the bill provided for a deputy director but that there was no plans to fill the position at present.

The bill also spells out the duties of the mobil units much more fully than they are described at present.

Chairman Smith asked about the pay for a prive citizen who was conscripted.

The answer was the pay would be \$15.00 per day.

Chairman Smith asked if there was any provision for protecting the job of a citizen who was conscripted.

The General could not answer this.

Assemblyman Ronzone asked if the Clark County Civil Defense Unit would be under the control of the agency.

Mr. Putman answered that the agency would provide funds but not have direct control over such a unit.

Chairman Smith asked where the money would come from if such a disaster occured.

The General answered from the Governor's emergency fund or a special appropriation from the Legislature.

AB 462 - Provides for continuty of government in case of enemy attack.

General Edsall explained that the bill would provide for the following things:

1. Restore the court system.

2. Extend the lifeline of the Governor.

3. Provide replacements for elected officials at a county level.

4. Provide for a new seat of government.

Chairman Smith explained to the committee that the bill was the result of SJR #4 of the 1961 Session, which was passed in the 1961 and 1963 Sessions of the Legislature and which passed the General Election in 1964. The first bill was presented in 1964 and passed the Assembly but not the Senate. No bill was presented in the 1967 Session.

AB 441 - Makes Columbus Day a legal holiday.

Chairman Smith reported that the State of Nevada Employees' Association was not opposed to the bill but were fearful that it might hurt the chances of AB 6 in the Senate and requested that no action be taken on the bill.

Assemblyman Bryan and Assemblyman Frazzini were appointed a special sub-committee to contact the Italian Clubs in the State and set up a hearing on March 22, 1971, on this bill.

AB 380 - Specifies number of staff as prerequisite for keeping state office open during noon hour.

Mr. Whittenberg said that the Department of Administration agreed with this bill, but suggested an amendment which would make it apply only to offices and commissions which have direct public contact.

Assemblyman McKissick explained that he had sponsored the bill because of the time differences, and many time eastern companies try to call the Secretary of State and do not get an answer.
