

MINUTES OF TRANSPORTATION COMMITTEE MEETING - 56TH NEVADA  
ASSEMBLY SESSION - APRIL 15, 1971

Present: Lowman, Kean, Howard, Ashworth, Prince and  
Valentine

Excused: F. Young

Also Present: Grant Davis, Counsel

Chairman Lowman convened the meeting of the Transportation  
Committee at 11:05 a.m. in Room 240.

A.B. 817 and 818: Howard moved to confirm earlier informal  
"do pass" action, Prince seconded and it was unanimously  
passed. (See signed notes attached.)

A.B. 518: Valentine moved to indefinitely postpone, Howard  
seconded and it was unanimously agreed. Valentine asked that  
Senator Monroe be notified by Bob Guinn.

Valentine discussed a resolution calling for a study of possible  
division combinations of the Department of Motor Vehicles.\*  
Howard moved to introduce the resolution. Valentine asked for  
"do pass" at the same time, Prince seconded and it was unanimously  
agreed.

Ashworth arrived.

Valentine said that there was a problem with A.B. 628 in that a  
"shall" is left in brackets. It will be amended in the Senate.

Grant Davis, Counsel, explained the purpose of A.B. 819, 820 and  
821 and said that they are to conform 618, 629 and 759 with  
S.B. 266 if they pass in the Senate. If the Senate bills are  
passed, the Assembly bills will amend Chapters 704 and 706 of  
NRS which we have repealed in S.B. 266. These amend 266 and  
puts those amendments into it if those bills are passed. They  
are valuable only if the Senate bills are passed.

Kean arrived.

A.B. 819, 820 and 821: Valentine moved "do pass", Ashworth  
seconded and they were unanimously passed.

Ashworth said that Senator Helen Herr, Senate Transportation  
Chairman, has advised him that they are going to pass A.B. 285  
with just the safety requirements in it.

The meeting was adjourned at 11:25 a.m.
