MINUTES - WAYS AND MEANS COMMITTEE
NEVADA STATE LEGISLATURE - 56th SESSION - FEB. 4, 1971

Chairman Young called the meeting to order at 2:45 PM.

Present: R. Young, Howard, Capurro, Hafen, F. Young, Brookman, Mello, Schofield, Swackhamer, Lingenfelter, Hilbrecht.

Chairman Young asked for corrections of the minutes of the Feb. 3rd meeting.

Mr. Hafen moved that the minutes be approved. Mr. Schofield Seconded the motion. Passed unanimously.

### PAGE 82 - NEVADA TAX COMMISSION

Appropriation from Other Funds - Governor recommends appropriation of \$88,200 in 1971-1972 and \$68,270 in 1972-1973. Increase is due to the conversion of collecting gasoline taxes to the computer. Cost will go down in 1972-1973.

Cigarette Tax Admin - Governor recommending appropriation of \$57,000 in 1971-1972 and 1972-1973. Increase due to higher tax and administrative costs went up.

New Positions - New positions requested by Agency were requested by Mr. Sheehan's predecessor. Governor recommends new position of Internal Auditor for \$10,683 in 1971-1972 and \$11,101 in 1972-1973. Internal Auditor needed to maintain Agency's budget and to make predictions and projections. This person would have an economic and statistical background.

Less Salary Savings - In 1970-1971 there was a salary savings of \$49561 which resulted from unfilled technical positions.

Out-of-State Travel - Governor did not recommend. See Out-of-State Audit Travel.

Out-of State Audit Travel - Governor recommending appropriation of \$17,000 in 1971-1972 and \$18,000 in 1972-1973. Agency has two out-of-state offices, and periodically Agency must send people out to do supervisory work.

Multi State Tax Compacts - Governor recommending appropriation of \$5,950 in both years of biennium.

Class Land Study - The Tax Commission is responsible for classifying agricultural land. Agency requesting appropriation of \$11,250 in 1971-1972. Governor did not recommend. The land people and cattle people have underwritten the Tax Commission's \$11,250 if Tax Commission doesn't get appropriation request. The study is being done by the University. (See Supp. Pg. A-2

Dues and Registrations - This is used primarily to pay county assessor's registration fees at training school for county assessors. Also is used for the training of property assessor's (covers registration fees at school).

EDP - Governor recommends appropriation of \$119,560 in 1971-1972 and \$91,098 in 1972-1973. The increased appropriation request in the first year of the biennium is primarily due to the conversion of the gasoline sales tax to the computer. General discussion on electronic data processing (Swackhamer, Hafen, Lingenfelter). Mr. Sheehan stated that the more up to date information that they have on a retailer, it is easier to keep track of accounts. Mr. Sheehan stated that the EDP figure in the budget is for a weekly print out.

# PAGE 90 - GOVERNOR'S COMMISSION ON STATUS OF WOMEN -

Mrs. Frazzini stated that this Commission needs appropriation to cover travel expenses, postage, and office expenses. In the past all people on the Commission have been appointed by the Governor (30-40 people throughout the State). Presently, Commission does not have an office. Mrs. Frazzini stated that there is an increased number of people bringing their problems to the Commission. This is a new appropriation. Chairman Young asked Mrs. Frazzini if she would supply the Committee with a line item budget for their appropriation request.
