MINUTES - WAYS AND MEANS COMMITTEE  
NEVADA STATE LEGISLATURE - 56th SESSION - MARCH 11, 1971

Chairman Young called the meeting to order at 7:30 A.M.

BDR 26-1935 - Abolishes unused special fund for maintenance  
and protection of the insane. (A.B. 709)

Mr. Lingenfelter moved for Committee introduction and DO PASS  
Mr. F. Young Seconded the motion.  
PASSED UNANIMOUSLY

BDR 31-1922 - Increases required content of school district  
audit report. (A.B. 710)

Mr. F. Young moved for Committee introduction.  
Mr. Capurro Seconded the motion.  
PASSED UNANIMOUSLY

BDR 34-1923 - Requires superintendent of public instruction  
to verify annually reports of daily average attendance and  
total classroom enrollment in Nevada public schools.

INDEFINITELY POSTPONED

BDR 34-1924 - Authorizes State Board for Vocational Education  
to expend money from Vocational Education gift fund. (A.B. 707)

Mr. Hilbrecht moved for Committee introduction  
Mr. F. Young Seconded motion.  
PASSED UNANIMOUSLY

BDR 31-1933 - Provides that interest on deposits of money of  
fund be created to such fund.

BDR 38-1788 - Authorizes Welfare Division to make continuing investigation as to eligibility of recipients' assistance. (This gives Welfare Division subpoena powers). (A,B. 708)

BDR 38-677 - Limits responsibility for child care of Welfare Division to dependent or neglected children. (A,B. 763)

Mr. F. Young moved we give this to Chairman of Health and Welfare.  
Mr. Hilbrecht Seconded the motion.  
PASSED UNANIMOUSLY

BDR 31-1920 - Revises and clarifies fiscal analysts duties with relation to count of monies and securities in state treasury. (A,B. 711)

Mr. Hilbrecht moved for Committee introduction.  
Mr. F. Young Seconded motion.  
PASSED UNANIMOUSLY

BDR 31-1931 - Clarifies duties of State Treasury respecting inactive deposits of public funds and securities. (A,B. 712)

Mr. Hilbrecht moved for Committee introduction.  
Mr. Capurro Seconded motion.  
PASSED UNANIMOUSLY

A.B. 331 - Places state law library under supreme court control.

Mr. F. Young moved a DO PASS with the following amendment:  
\$64,000 will be transferred out of the State Library's budget to the Supreme Court's budget.

PASSED UNANIMOUSLY

A.B. 220 - Provides for special state election to be held June 8, 1971, on proposal to amend Nevada constitution to reduce minimum voting age to 18 years.

A.B. 235 - Requires health division to pay certain counties to provide certain laboratory services. Dr. Carr stated that we have a bigger and better laboratory up here in the North. Main concern in Clark County is that VD services will not be good. Dr. Carr stated that presently they are performing a trial run on consolidated lab regarding testing services. Following tests are being sent via mail from Clark County to lab: Specimens, VD specimens, milk and water samples.

A laboratory in Clark County would cost approximately \$136,644; funding would come out of Health Division's funds.

Mr. Hilbrecht stated that bill is to provide that certain district health departments would qualify for state subsidy if county qualified. He mentioned that he had a letter which states this would save some \$80,000 by consolidating.

Mr. Hilbrecht expressed his desires that the Committee hold action on bill until he could contact people to come up to Carson City and speak in favor of having a lab in Clark County.

Mr. Schofield stated that he was not in favor of moving health services up to the Northern part of the State. He felt that this should be within the community.

Dr. Carr stated that 70-80% of VD testing is from Clark County.
