MINUTES - WAYS AND MEANS COMMITTEE NEVADA STATE LEGISLATURE - 56th SESSION - MARCH 17, 1971

Chairman Young called the meeting to order at 3:20 P.M.

UNIVERSITY OF NEVADA SYSTEM CAPITAL IMPROVEMENTS

Refer to handout from University of Nevada System: <u>Revised</u> 1971-73 Capital Improvement Program Request

Chancellor Humphrey reviewed the highlights of the revised capital improvement requests for UNS.

President Zorn reviewed capital improvement request priorities for UNLV. He remarked that due to enrollment expansion, the campus is experiencing a physical plant deficit and physical plant development must be commensurate with growth. Enrollment is growing at rate of 12% per year (25% each biennium). Population is increasing in LV area and there is an increasing demand for educational opportunity. UNLV is projecting an enrollment of 10,000 students by end of decade. UNLV has less than half of instructional space than UNR. Facilities are being operated from 8:00 A.M. until 11:00 P.M. UNLV is in addition using facilities not designed for instruction and renting space. Based on 69-70 statistics, UNLV plant operates at 121% of its capacity. He remarked that new education, theatre and humanities buildings will be filled to capacity by time they are completed.

President Zorn stated that construction is not catching up with enrollment. President Zorn commented on the following capital improvement priorities for UNLV:

UNLV Land Acquisition (Priority #1) - \$470,000 is requested. Some of the land is near the new construction and acquisition of such land is necessary for parking; part of land is needed for relocation of Swenson Avenue. This street would be rerouted around periphery of campus to prevent high density traffic pattern going right through middle of campus.

<u>UNLV Site Development (Priority #3) - \$618,000 is needed for</u> additional parking (need to accommodate 1,600 more vehicles); \$646,000 is needed for additional lighting in parking lots and around campus buildings; \$338,000 for landscaping around new buildings going up and for drainage topographic map of campus; \$83,000 is requested for sidewalks, curbs, gutters for Maryland Avenue, University Road and Harmon; utilities distribution system -\$130,000 requested for electrical system and \$85,000 requested for natural gas system.

UNLV Athletic Fields (Priority #5) - Appropriation of \$826,000 requested. President Zorn stated that present fields are submarginal and totally inadequate.

UNLV Gymnasium (Priority #6) - State appropriation requested in sum of \$2,217,000 and \$2,570,000 in revenue bonds to be amortized by capital improvement fund. Present Gym was planned in 1961 to accommodate 1200 students. Building is submarginal. Many of the offices here are in remodeled closets. Health Department has advised UNLV that shower facilities in Gym are overcrowded and unsanitray. In addition, he remarked that they must train PE teachers and need proper facilities; in addition, there is a need for special performance labs and adventually hope to have a swimming pool.

President Miller commented on the following capital improvement priorities for UNR:

UNR Flood Control, Peavine Mountain (Priority #2) - Appropriation of \$116,000 requested, and is recommended by Governor.

UNR Site Development & Utility Extension - Appropriation of \$436,000 being requested. Major project is addition of a fourth generator in central heating plant. \$45,000 requested for extension of a heat trench. \$16,000 of appropriation to be used for placing additional high tension lines underground. An elevator is needed in a four story engineering building. \$10,000 requested for additional underground cables. \$41,999 is requested to extend parking near north end of campus.

Mr. Lingenfelter suggested remodeling freight elevator so it could be self operated for special students who are handicapped and suggested that other students could use stairs.

<u>UNR P.E. Complex, Phase I (Priority #7)</u> - UNR requesting authorization to use their own bonding capacity to move ahead in first phase. Present PE building was designed for 1200 students and present enrollment is 6700 students. Mr. Swackhamer referred to a bill before Congress authorizing \$5,000,000 a year for capital construction. Chancellor Humphrey remarked that Board of Regents are contacting our Senator's in Washington, D.C.

Dr. Donnley commented on the following capital improvements for Elko Community College:

<u>CCD Instructional Building, Elko (Priority #10)</u> - He stated that they are withdrawing requests for revised priorities 8 and 9. Building in Elko for vocational and technical programs is more important. Construction would provide for computer science Lab, in addition labs for nursing program, agriculture programs, construction programs, drafting and electrical engineering, automobile mechanics and culinary arts.

Dr. Donnley stated that CCD desires to begin capital improvements in Elko before expanding to Clark County and Western Nevada. The above building would be 17,000 square feet. Site consists of 57 acres. \$42.30 a square foot.

Mr. Lingenfelter moved the budget be amended as follows: Cut in state travel to \$1200 in 71-72 and 72-73. Delete \$2,000 from contract services in each part of biennium. Change Regular appropriation to \$13,934 71-72 and to \$16,246 in 72-73, and DO PASS as Governor recommended and amended. Mr. Swackhamer Seconded the motion. PASSED UNANIMOUSLY

PAGE 334 - GAMING CONTROL BOARD

Mr. Swackhamer moved to amend budget as follows: Add 5 auditors at \$14,200 in 71-72 and \$15,200 in 72-73; one Office Manager at \$14,200 in 71-72 and \$15,800 in 72-73; add one audit supervisor at \$16,200 in 71-72 and \$17,800 in 72-73. Mr. Capurro seconded the motion
