PAGE A-27 - CAPITAL IMPROVEMENT PROGRAMS

Opening remarks were made by the Subcommittee on Capital Improvements (Swackhamer and Brookman). Mr. Swackhamer gave history of State Planning board. Mr. Swackhamer remarked that many times when bids are approved they do not include the furnishings. Then agencies come back at a later date with a supplemental. Mrs. Brookman pointed out the problem of controlling capital improvement costs.

Mr. Swackhamer did not believe that the architects were at fault being that there is no real owner of the building. He remarked that the taxpayers are represented by the planning board and no one knows where it goes from there. His feeling was that the State Planning Board always goes "the grand way".

Mr. Hafen stated that control is always with the Planning Board and Planning Board was established to take the place of the owner and apparently they have not done this. Mr. Hafen questioned priorities of University System site development.

PAGE 260 - NEVADA GIRLS TRAINING CENTER

Chairman Young remarked that he had talked with the Governor yesterday regarding this training center. The Governor's recommendation is that we stay at \$200 a month per girl, and if family can afford it, charge them in addition and allow the school to keep this money.

Discussion (Capurro, Swackhamer, Lingenfelter, Hilbrecht) on states cost per girl and family cost. Mr. Capurro remarked that up to 75% of girl's parents would not be able to pay. Mr. Lingenfelter stated that the judges would probably commit girls to this school whose families had money.

Mr. Hilbrecht felt that we needed a bill for this.

Mr. F. Young requested time to research this.

Mr. Swackhamer requested a bill to charge the family additionally and still allow the State to pay the \$200 per girl. If parents can afford it, they will have to contribute to part of the cost.

PAGE 214 - OUT-PATIENT CLINICS

Mr. Swackhamer moved that Ways and Means hold firm on this budget and not concur with Senate Finance Mr. Hilbrecht Seconded the motion PASSED UNANIMOUSLY

PAGE 17 - CONTROLLERS OFFICE

Mr. Lingenfelter moved authorization of increase of \$50,000 each year in the biennium with provision that it not be General Fund appropriation but be financed by agency charges to be determined by a study of Dept. of Administration and HEW approval. Mr. Hilbrecht Seconded the motion PASSED UNANIMOUSLY Assembly Committee on Ways and Means

PAGE 322 - PUBLIC SERVICE COMMISSION

Chairman Young remarked that he had received a letter from the Public Service Commission requesting a new position of a railroad inspector to comply with the Railroad Safety Act passed by Congress. Appropriation of \$12,592 requested for salary, in-state travel, etc.

Mr. Hilbrecht moved budget be reopened, amended to include new position of railroad inspector. Mr. Lingenfelter Seconded the motion PASSED UNANIMOUSLY
