MINUTES - WAYS AND MEANS COMMITTEE
NEVADA STATE LEGISLATURE - 56th SESSION - APRIL 15th, 1971

Chairman Young called the meeting to order at 8:00 A. M.

S. B. 179 - Directs conveyance of not to exceed 200 acres of state owned real property in Carson City to University of Nevada for community college purposes.

Senator Pozzi referred to a Site Development Report concerning proposed sites for community college.

This bill makes the property available to the Board of Regents for five years and if they do not select this property it will go to the Department of Conservation or to Buildings and Grounds.

Proposed site #1 is north of Carson City. Most proposed sites are South of Reno, and this area is within the population growth area.

S. B. 531 - Makes general fund appropriation for support of Virginia City historic district commission.

Mr. Gray remarked that this small appropriation would enable the restoration of Virginia City to get underway. He remarked that if this bill was passed, they would not come back and ask for more money.

Mr. Gray testified that this was not a local problem but felt that Virginia City had historical significance not only to the State but within the far west.

In answer to Mr. Swackhamer's question regarding what the appropriation would be used for, Mr. Gray replied that it would be used to set up an office, to hire a clerk typist and an investigator. Naturally the small appropriation would not cover all of this and he stated that the investigator would volunteer part of his services. Many people have volunteered to assist in the restoration.
