3. AB 211

Assemblyman Vergiels stated he was concerned, after listening to Mr. Colton at last Thursday's meeting, about being able to catch anyone who tried to vote twice, but Assemblyman Huff believed it might serve as a deterrent. Chairman Foote stated she didn't believe/would look at NRS 293 so Assemblyman Smith suggested posting it. Assemblyman Ford commented that it didn't designate applying only to the State of Nevada and wondered about the possibility of someone voting in Los Angeles and then coming up to Nevada. Assemblyman Huff advised it could only apply to Nevada. Assemblyman Vergiels asked if they would like to have it amended to indicate it be posted in every polling place or some conspicuous place and Chairman Foote stated she believed it would be a good idea. Assemblymen Ford and Gojack stated it must be big enough and conspicuous so it can be noticed so Assemblyman Vergiels asked if the size of the print should be specified? It was determined it should be the same size as the notice that no person should be on the same side of the street of any entrance to the polling place to solicit a vote or ask for whom voting, and it was determined it should be posted in the county clerk's office, the registrar's office, and listed on the sample ballot so the voters will know about it before the election starts.

Chairman Foote asked it anyone in the audience wanted to discuss AB 211. No one did, so Chairman Foote stated they will wait and take action on this bill at the time they see the amendment.

4. SB-42

$5. \underline{AB-9}$

Assemblyman Smith asked if they could once again take up AB-9 because they have discussed it several times and have had some problems, particularly on page 2, line 45, stating there is even a more serious problem on page 3, line 31, and another problem is in the language we are omitting in the notice. He stated he believed if it were changed on page 3 as proposed it would permit a local faction to call a meeting and deny proxy and keep participation and, therefore, the votes down. He stated he believes he understands the reason the bill was introduced but believes it works a greater hardship on both parties than it is intended to carry. Therefore, if a motion is in order, he would like to move for an indefinite postponement on the bill. Assemblyman Gojack seconded the motion. Chairman Foote asked if we would, then, be leaving the law as it is and Assemblyman Smith stated yes, the law would return to as it is now. Action taken as follows:

- 6. Chairman Foote asked if anything else was to come before the Committee. Assemblyman Ford stated she would like to check on the following:
 - a. Cranford (Crawford) has asked for a bill for Stan (Colton) to ask for an appointment of election board officials? Assemblyman Crawford stated he had.
 - b. Chairman Foote had been furnished guidelines from Mr. Winters which would change the order of the candidates listed on the ballot to lot rather than alphabetical? Chairman Foote agreed she had. Assemblyman Ford asked if it had been determined by the Committee, after discussion, whether there was no point in getting a bill drawn up. The Committee concurred.
 - c. Something was mentioned about changing the primary election date from the first day of school to either earlier or later. Assemblyman Vergiels advised he had a bill on his desk now which changed the date of the primary to the last Tuesday in August instead of the first Tuesday in September. He had it brought up so the Committee could review it (#BDR 24-889). Assemblyman Ford made motion for Committee introduction; seconded by Assemblyman Gojack. Action taken as follows:
