The meeting was called to order at 8:25 a.m. by Chairman Bennett for the purpose of discussing AB 724.

Mr. LaBodie, State Welfare Department, stated they had requested this bill to insure they received notice and had a hearing prior to a court placing a child in their custody. The State Welfare Department is having a problem in this regard because Washoe County Health Department does not notify them when a child is to be placed in their custody and the first notice they have is a court order. They have no opportunity to study the child and its problems or to make arrangements for a home. They are just told, "here is the child - pay the bill", and they would like an opportunity to participate in planning for the child.

When a County turns a child over to the State the County pays one-third and the State two-thirds.If the County retains custody they must pay the whole bill, and the State should have an opportunity to participate in the decision of the court by attending a hearing.

Mr. Holland stated that under due process of law everyone is entitled to notice and a hearing, and certainly the State Welfare Department should be.

Mr. LaBodie, Mr. Holland and Mrs. Handley requested that the bill be amended as follows: On line 15 the italicized matter should be a separate paragraph numbered "2." Paragraph 2 should be renumbered 3, and paragraph 3 should be renumbered 4.

Committee action:

AB 724 - Mr. Wittenberg made a motion "Amend, and do pass as amended. Second by Mr. McNeel. Unanimously passed. Assembly HEALTH & WELFARE COMM. MIN. MAR. 23, 1973 Page 2

Chairman Bennett asked the Committee's opinion of introducing as bills <u>BDR 34-1632</u> and <u>BDR 11-1370</u>. Mr. Getto moved they be introduced, and Mr. McNeel seconded. Unanimously agreed.
