JUDICIARY COMMITTEE 57th NEVADA ASBEMBLY SESSION

MINUTES

APRIL 14, 1973

The meeting was called to order by Mr. Keith Hayes, Chairman.

MEMBERS PRESENT: MESSRS: HAYES, BARENGO, GLOVER, TORVINEN, FRY, LOWMAN

and MISS FOOTE.

MEMBERS ABSENT: MESSRS: HICKEY AND HUFF

Mr. Hayes announced that the first item of business would be consideration of concurrence in several Senate amendments.

A.B. 66 has Senate amendments which would eliminate drinking and gaming for the 18 year olds.

Mr. Lowman said that he and Senator Foley were having the LCB check into the possibility of including a reciprocal agreement whereby if 18 year olds were allowed to drink in their home state it would be allowed in Nevada.

Mr. Lowman moved to NOT CONCUR with the Senate amendments, Mr. Fry seconde MOTION CARRIED DO NOT CONCUR WIRH SENATE AMENDMENTS TO A.B. 66

On A.B. 210 the amendments changed Page 1, Line 7 to read "with intent to destroy, and deleted "if placed or thrown" from Page 1, Line 16.

Mr. Lowman moved to condur, Mr. Torvinen seconded.

MOTION CARRIED DO CONCUR WITH SENATE AMENDMENTS TO A.B. 210

The suggested Senate amendment to A.B. 389 changed "may be served by telegraph" to "may be transmitted by telegraph".

Mr. Fry moved DO CONCUR WITH SENATE AMENDMENTS TO A.B. 389 Mr. Lowman seconded.

MOTION CARRIED DO CONCUR WITH SENATE AMENDMENTS TO A.B. 389

The amendments to A.B.~434 delete on Page 1, Lines 10 thru 12. Mr. Fry moved DO CONCUR WITH SENATE AMENDMENTS TO A.B.~434, Mr. Lowman seconded.

MOTION CARRIED DO CONCUR WITH SENATE AMENDMENTS TO A.B. 434.

 $\underline{\text{A.J.R. 10}}$ was amended by the Senate to allow the Supreme Court to hear arguments anywhere in the state rather than just Carson City and Clark County.

Mr. Torvinen moved DO CONCUR, Mr. Fry seconded.

Mr. Glover voted against the motion.

MOTION CARRIED DO: CONCUR WITH SENATE AMENDMENTS TO A.J.R.10

S.B. No. 151 SUMMARY-Provides penalty for violation of state park system regulations.

Mr. Glover moved to recommend DO PASS, Mr. Barengo seconded. Mr. Lowman voted against the motion.
MOTION CARRIED DO PASS S.B. 151

S.B. No. 147 SUMMARY-Enlarges class of persons who may be sentenced to concurrent terms of imprisonment.

Mr. Torvinen moved to recommend DO PASS, Miss Foote seconded.
MOTION CARRIED DO PASS S.B. 147

Mr. Fry recommended postponing consideration of <u>S.B. 64</u> until a future date. The Committee agreed. S.B. 64 HELD

A.B. No. 170 SUMMARY-Making assault on a member of the National Guard a felony.

Mr. Fry moved INDEFINITE POSTPONMENT, Miss Foote seconded. MOTION CARRIED INDEFINITE POSTPONMENT A.B. 170

S.J.R. 22 SUMMARY-Proposes to amend section 8 of article 6 of Nevada constitution to permit legislature to extend jurisdiction of justice courts.

Mr. Barengo pointed out that we have already done this in <u>A.J.R. 15</u>. He also said that this bill is not stated properly.

HELD

On <u>S.B. 282</u>, a debt adjusters regulation, Mr. Barengo said that he was informed that the <u>assembly bill 430</u> which is similar, has not been scheduled for consideration in the Senate. Mr. Lowman said that there must have been some conflicting information, because he was informed that it would be ready for the governor's signature within a day or so. Mr. Glover said that he felt legislation in this area is badly needed.

Mr. Glover moved to recommend DO PASS WITH AMENDMENTS, Miss Foote seconded Mr. Fry pointed out that testimony on these bills was that the assembly bill has already been amended, and this bill would still require amendments.

Voting against the motion: Lowman, Fry, and Hayes. MOTION FAILED.

S.B. 410 SUMMARY-Prohibits advertising of obscene material. No Motion on this bill.

PAGE THREE

Mr. Hayes said he would now consider a motion on <u>S.B. 387</u> the nurses conscience clause concerning abortion.

Mr. Torvinen moved to recommend DO PASS, Mr. Glover seconded. MOTION CARRIED DO PASS S.B. 387

A.B. No. 319 SUMMARY-Permits licensed physicians to perform abortions except where limited by certain conditions.

Mr. Barengo announced that he had worked on amendments to more strictly regulate circumstances, records etc.

Mr. Barengo moved to accept the amendments and put the bill on the floor with NO RECOMMENDATION. Mr. FRY SECONDED.

Mr. Lowman voted against the motion.

Mr. Hayes abstained from voting.

MOTION CARRIED AMEND A.B. 319 AND PASS OUT OF COMMITTEE WITH NO RECOMMENDATION.

Mr. Hayes informed the Committee that he would be in Houston for health reasons on Monday and Tuesday. Mr. Barengo will Chair the Committee in his absence and take whatever action he deems necessary.
