Meeting of the Labor and Management Committee was called to order 5:45 on March 6, 1973 by Chairman Banner. The purpose of the meeting was to discuss and take some action on <u>AB 233</u> <u>AB 245</u>, <u>AB 247</u> and <u>AB 349</u>.

<u>AB 233</u> - Mr. Ullom stated that we had two different times when we heard testimony and that he felt it was time to take some action on it and he therefore made the motion to "Do Pass". Mr. Bickerstaff seconded the motion. There was no dissenting votes.

<u>AB 245</u> - Mr. Ullom presented an amendment that would make provisions for deductions for collective bargaining dues changing in amount. Mr. Ullom made the motion "Do Pass as Amended" and Mr. Bickerstaff seconded the motion. There was no opposition.

<u>AB 247</u> - Mr. Barengo said that he had questioned the constitutionality of delegating to some other body other then the legislator the authority to set jurisdiction. He had worked on it with the bill drafters and Mr. Jones and had come up with the following amendment:

Line 24 to read : "workman shall be in accordance with the jurisdictional classes recognized in the locality that the work is performed"

<u>AB 349</u> - Mr. Barengo was not able to the get the amendments completed for this meeting. Chairman Banner agreed to hold it until a later date.

Chairman Banner announced that <u>AB 375</u> was scheduled for a hearing on Thursday March 8, 1973 and that there was to be a joint hearing with the Senate tomorrow (March 7) at 3:00 to hear testimony on the NIC legislative package.
