RULES OF THE WAYS AND MEANS COMMITTEE

1973 SESSION

- 1. A quorum consists of at least five (5) committee members.
- 2. It will require at least a quorum to hear a bill or budget.
- 3. It will require a simple majority of the committee to pass or reject a bill or budget.
- 4. It will require a two-thirds majority of all committee members to reconsider an action on a bill or budget.
- 5. The committee shall address the chair at all times for permission to be heard.
- 6. There will be no committee action on bills or budgets during a hearing.
- 7. The names of movers and seconds and the vote tally shall be entered on the attached "Legislation Action" form or "Budget Action" form and attached to the minutes.
- 8. The Chairman will vote only to break a tie vote.
