RULES OF THE WAYS AND MEANS COMMITTEE

1973 SESSION

1. A quorum consists of at least five (5) committee members.
2. It will require at least a quorum to hear a bill or budget.
3. It will require a simple majority of the committee to pass or reject a bill or budget.
4. It will require a two-thirds majority of all committee members to reconsider an action on a bill or budget.
5. The committee shall address the chair at all times for permission to be heard.
6. There will be no committee action on bills or budgets during a hearing.
7. The names of movers and seconds and the vote tally shall be entered on the attached "Legislation Action" form or "Budget Action" form and attached to the minutes.
8. The Chairman will vote only to break a tie vote.
