WAYS AND MEANS COMMITTEE - NEVADA STATE LEGISLATURE - 57th SESSION

March 20, 1973

Meeting called to order by Chairman Mello at 8:05 AM in the Ways and Means Committee Room.

PRESENT: Chairman Mello, Vice-Chairman Schofield, Messrs. Dreyer, Robinson, Capurro, Howard, Smith, Prince and Hafen.

Motion to approve the Minutes of March 12-16, 1973, made by Mr. Dreyer. Second by Mr. Howard. Motion passed.

A.B. 267: Mr. Ray Knisley presented the explanation of the Bill.

Mr. Knisley and Senator Settelmeyer were called upon last year to make recommendations on improving the present act on soil conservation. They found that the old act had powers that were extremely broad in scope and that it was not working properly. The proposed legislation creates a division in the Department of Conservation & Natural Resources, and a soil conservation commission. The Commission will have nine members, two of which will be ex officio (Dean of Agriculture at the University and the Director of the Department of Agriculture). This legislation does not have any State funds but it does have very material Federal funds. Averages about 1-1/2 million dollars per year. This Commission will be extremely valuable in implementing the State Land Use Act, and in producing the Land Use Plan. No salaries will be paid other than to the Administrator and his secretary.

Mr. Howard stated that it was in the Agriculture Committee for two months and guite a few amendments were made to the original bill. The Agriculture Committee now feels that it will do the job as intended and is much better than the present statute.

Mr. Prince concurred that this was a step in the right direction.

This bill would change the name of the fund from revolving to permanent. Increase the amount of the fund to \$10,000. Makes provisions for the non-reversion of the fund at the end of a fiscal year. Places authority for purchases under the State Purchasing Agent.

Re: Proposed Expansion of Food and Drug Program

Gentlemen:

The cooperative meat inspection program between the State of Nevada and the U.S. Department of Agriculture has been in operation since July 1, 1969. The slaughterhouses and wholesale meat and poultry establishments, as well as the overall program, have been termed "equal to" Federal inspection by U.S.D.A. since December 1970.

Several of our State inspected plants have gone under Federal inspection during this time and at the present time approximately 1/3 of the plants remaining under State inspection have expressed interest in going under the Federal inspection program. Inspection under the Federal program permits plants to ship interstate while State inspection limits their shipments to Nevada.

Since this natural transition is taking place it is requested that the Legislature give due consideration to turning the present cooperative program over to U.S.D.A. and that the State's share of the funds for meat inspection presently in the Governor's proposed budget be redirected to the attached proposed program for the expansion of food and drug activities in the field of consumer protection.
