## COMMITTEE ON FEDERAL, STATE AND LOCAL GOVERNMENTS

Minutes of Meeting - April 3, 1973

The thirty-sixth meeting of the Committee on Federal, State and Local Governments was held on the 3rd day of April, 1973, at 7:00 P.M.

Committee members present:

Chairman Gibson called the meeting to order. The committee discussed and took action on the following legislation:

- AB-290 Requires secure premises to be maintained for the division of archives and changes the name thereof.
- AB-80 Establishes new procedure for retention and disposal of state records.
- AB-376 Provides records destruction procedure and enables records management program for local governments.

Chairman Gibson explained that these bills had been drafted at the request of the Department of Administration.

- AB-80 Senator Swobe moved "Do Pass." Seconded by Senator Foley.
  Motion carried.
- AB-290 Senator Drakulich moved "Do Pass." Senator Swobe seconded.

  Motion carried.
- AB-376 Senator Swobe moved "Do Pass." Seconded by Senator Walker. Motion carried.

SB-591 Requires consent of county Commissioners before construction of state highway in counties.

Senator Swobe moved to "Hold Indefinitely." Seconded by Senator Walker. Motion carried.

Allows the establishment of limited medical facilities and ambulance services for outlying areas.

Senator Swobe moved "Amend and Do Pass." Seconded by Senator Foley. Motion carried.

AB-11 Makes various technical changes in election laws.

Senator Foley moved "Do Pass as Amended." Seconded by Senator Swobe. Motion carried.

AB-70 Empowers board of county commissioners in smaller county to increase its number.

Senator Dodge moved "Do Pass." Seconded by Senator Swobe. Motion carried.

AB-256 Reduces frequency of required reports of Indian affairs commission.

Senator Dodge moved "Do Pass." Seconded by Senator Swobe. Motion carried.

AB-316 Changes name of county clerk's register to registrar of voters' register.

Senator Swobe moved "Do Pass." Seconded by Senator Hecht. Motion carried.

AB-369 Removes prohibition against certain local ordinances relating to traffic accidents.

Senator Swobe is to check with Assemblyman Torvinen on this bill.

AB-409 Enables county clerk to delegate initial Selection and training of members of election boards to chairmen.

Senator Dodge moved "Do Pass." Seconded by Senator Drakulich. Motion carried.

AB-437 Provides compensation for hospital trustees in smaller counties.

Senator Swobe moved "Do Pass." Seconded by Senator Foley. Motion carried.

AB-458 Removes restriction on carrying forward accumulated unused sick leave for employees in public service.

Senator Swobe moved to "Hold Indefinitely." Seconded by Senator Walker. Motion carried.

AB-481 Provides for appointment of county surveyor.

Senator Swobe moved "Do Pass." Senator Walker seconded. Motion carried.

AB-504 Clarifies accounting procedures to be used in computing transactions of the working capital and operating fund under the State Purchasing Act.

Senator Dodge moved "Do Pass." Seconded by Senator Drakulich. Motion carried.

AB-512 Implements 1972 constitutional amendment relating to initiative.

Senator Drakulich moved "Do Pass." Seconded by Senator Swobe. Motion carried. AB-527 Provides for annual assessments on general improvement districts.

Senator Dodge moved "Do Pass." Seconded by Senator Swobe. Motion carried.

AB-550 Creates Nevada American revolution bicentennial commission.

Senator Swobe moved "Do Pass and re-refer to Finance."
Seconded by Senator Dodge.
Motion carried.

AB-565 Allows increase in state fire marshal's inspection and license fee.

Senator Hecht moved "Do Pass." Senator Swobe seconded. Motion carried.

AB-582 Provides procedure for refund or credit of excess tax assigned to county fair and recreation board.

Senator Drakulich moved "Do Pass." Seconded by Senator Swobe. Motion carried.

AB-583 Provides for confidentiality of information obtained as result of imposition of license taxes.

SEnator Walker moved "Do Pass." Seconded by Senator Swobe. Motion carried.

AB-599 Permits employee organizations to be represented by a licensed attorney in negotiations under Local Government Employee-Management Relations Act.

Senator Foley moved "Do Pass." SEconded by Senator Swobe. Motion carried.

AB-615 Amends Carson City charter and NRS to provide for the office of treasurer.

Senator Hecht moved to "Hold Indefinitely." Seconded by Senator Swobe. Motion carried.

AB-630 Creates charter committee for City of Sparks and requires opinion vote on form of government for Sparks.

Senator Dodge moved to "Hold until we get letter." Seconded by Senator Hecht. Motion carried.

AB-649 Allows retired public employee to have insurance premium deducted from retirement payments.

Senator Dodge moved "Do Pass." Seconded by Senator Swobe. Motion carried.

AB-653 Provides for compensation of directors of county fire protection districts.

Senator Drakulich moved to "Hold Indefinitely." Seconded by Senator Dodge. Motion carried.

AB-751 Creates the local government purchasing study commission.

Senator Dodge moved "Do Pass." Seconded by Senator Foley. Motion carried.

AB-760 Permits the central data processing division to provide technical advice to local governments.

Senator Swobe moved "Do Pass." Seconded by Senator Foley. Motion carried.

AB-835 Equates private conveyance travel expense allowances of county, township officers and employees to amount allowed state officers and employees; removes limitation on living expenses of township officers.

Senator Walker moved "Do Pass" on AB-835. Seconded by Senator Swobe. Motion carried.

Chairman Gibson then discussed the employee management relations board and the agenda for next Wednesday.

There being no further business, the meeting was adjourned.
