MINUTES OF MEETING HELD

24th DAY OF JANUARY, 1973

The meeting was called to order at 9:04 a.m. Senator Close in the Chair.

S.B. 19 - Corrective legislation eliminating Narcotic and Dangerous Drug Division from State Crime Commission to avoid duplication of functions.

Senator Bryan remarked that he had been contacted by persons concerned that this bill would renew a battle which was resolved last session by allowing the Division to accept money. Mr. Wooster testified that in drafting the bill, they had just followed the advice of Carrol Nevin of the Crime Commission.

Further testimony will be heard from all parties interested.

S.B. 12 - Technical amendment correcting internal reference.

Mr. Wooster testified that this bill would delete an incorrect reference to NRS 136.170 and substitute reference to NRS 136. 120 since that is the section dealing with county school districts with enrollment of 1,000 or more.

Senator Dodge moved "DO PASS." Seconded by Senator Bryan. Motion carried.



S.B. 29 - Permits operation of ambulance under certain conditions by drivers and attendants not licensed by Health Division.

To include exemption for volunteer ambulance drivers in emergency situations or in towns having a population of less than 1,000 from a misdemeanor fine if not licensed by the State Department of Health under NRS450A.080. This was amended into the criminal section under NRS202.590 in 1971 but not included in this licensing section of NRS.

Senator Bryan moved "DO PASS." Senator Dodge seconded the motion. Motion carried.

S.B. 30 - Technical amendment updating language of provisions for treatment of minors for drug abuse and provision prohibiting drug users from transporting explosives.

Removes obsolete reference to narcotic drugs in conformance with Controlled Substances Act.

Lines 15 through 20 were deleted from Page Two since they were not included in the text of the enrolled bill. They were not adopted by the second conference committee last session and should not have been included in the bill.

Senator Swobe moved "DO PASS." Seconded by Senator Dodge. Motion carried.

S.B. 35 - Corrects typographical error in law relating to admissibility of evidence.

Correct typographical error by deleting the word "of" and inserting the word "or".

Senator Bryan moved "DO PASS." Motion seconded by Senator Swobe. Motion carried.

S.B. 36 - Makes technical corrections in law specifying property exempt from execution.

Eliminate redundant repitition of "office equipment."

Senator Dodge moved "DO PASS." Seconded by Senator Bryan. Motion carried.

S.B. 37 - Makes technical correction in grand jury selection law.

This bill would make provision for boards of county commissioners which consist of seven members, such as Clark County has.

Senator Bryan remarked that a bill would be introduced which would attempt to change the grand jury selection system. Senator Hecht suggested that the committee hold this bill until they can examine the other bill on this same subject.

Senator Hecht moved that no action be taken on this bill at this time. Motion seconded by Senator Bryan. Motion carried.

S.B. 39 - Repeals obsolete provision relating to extended unemployment compensation benefits.

Deletes reference to NRS612.3788, which was repealed.

Senator Swobe moved "DO PASS." Seconded by Senator Foley. Motion carried.

S.B. 40 - Technical amendment inserting correct name of Nevada Bureau of Mines and Geology.

Senator Swobe moved "DO PASS." Seconded by Senator Foley. Motion carried.

Minutes of January 23rd meeting approved.
