COMMERCE COMMITTEE - NEVADA STATE LEGISLATURE - 58TH SESSION

JANUARY 29, 1975

The meeting was called to order by Chairman Robinson at 2:05 P.M.

A motion was made by Mr. Wittenberg that the minutes of the previous meeting be approved. Mr. Schofield seconded the motion. The minutes were unanimously accepted.

Mr. Demers presented two bills which he felt the Commerce Committee might want to introduce. One was BDR 54-187 which:

Allows practitioners of Western Medicine to obtain licenses in traditional Chinese medicine.

He explained that it would allow a dentist, for example, to utilize acupuncture needles to act the same way as novocain. It would be giving a limited license to use acupuncture needles.

A motion was made by Mr. Hickey that this bill be introduced by the committee. Mr. Demers seconded the motion. (See attached Legislation Action form for roll call vote.) This motion did not pass with a committee majority.

The second bill Mr. Demers presented for committee introduction was BDR 54-192 which:

Changes the name from Chinese medicine to Oriental medicine regarding acupuncture.

Mr. Hickey moved that this bill be introduced by the Commerce Committee. Mr. Harmon seconded the motion. (See attached Legislative Action form for roll call vote.) This motion was passed and this bill will be introduced by the Committee.

Discussion then turned to AB 69 which calls for:

Technical amendments to correct internal reference
and name designation in NRS chapter 639.

This bill would clear up the title of a "pharmaceutical clerk" and an "intern pharmacist". Mr. Wittenberg wondered if this bill had anything to do with who will do the work of a pharmacist in his absence and went on to comment on the problem there has been in Northern Nevada in this regard. He stated that we need a definition of "intern pharmacist".

It was decided there would be a public hearing on this bill on February 12, 1975 at 3:00 P.M.

With no further business, the committee was adjourned by Chairman Robinson at 2:22 P.M.
