AB 724 - Mr. Demers moved that this bill be "do passed". This was seconded by Mr. Harmon and carried the committee with Mr. Getto and Mr. Benkovich not voting.

AB 707 - Mr. Demers moved that Amendment No. 8464 to AB 707 be adopted. This was seconded by Mr. Getto and carried the committee. Mr. Getto moved that AB 707 be "do passed as amended". This was seconded by Mr. Schofield and carried the committee unanimously.

AB 601 - Mr. Demers moved that Amendment No. 8702 be adopted to AB 601. This was seconded by Mr. Getto and carried the committee. Mr. Demers moved that AB 601 be "do passed as amended". This was seconded by Mr. Getto and carried the committee unanimously.

AB 555 - Mr. Harmon moved that this bill be "Indefinitely Postponed". This was seconded by Mr. Getto and carried the committee unanimously.

AB 549 - Mr. Getto moved that this bill be "do passed". This was seconded by Mr. Harmon and carried the committee with Mr. Benkovich voting "no".

AB 474 - Mr. Hickey moved that this bill be "Indefinitely Postponed This was seconded by Mr. Benkovich and carried the committee unanimously.

AB 642 - Mr. Demers moved that this bill be "Indefinitely Postponed". This was seconded by Mr. Getto and carried the committee unanimously.

 $\overline{\text{AB}}$  643 - Mr. Demers suggested that the bill be amended to delete  $\overline{\text{lines}}$  18 and 19 and have it apply only to electric, telephone, and gas within the State of Nevada. If this cost could not be past on to the rate payer, he felt the Public Service Commission could use this as a detrimental tool against a utility.

Mr. Harmon then moved that AB 643 be "indefinitely postponed". This was seconded by Mr. Hickey. Mr. Demers, Mr. Schofield and Mr. Getto voted "no". Mr. Wittenberg was "not voting". This created a tie with only four "aye" votes.

Mr. Demers then moved that <u>AB 643</u> be "do passed as amended". This was seconded by Mr. Wittenberg. The motion failed with four dissenting votes: Mr. Benkovich, Mr. Harmon, Mr. Hickey, and Mr. Robinson.

AB 732 - Mr. Harmon moved that this bill be "indefinitely postponed". This was seconded by Mr. Wittenberg and carried the committee with Mr. Demers voting "no" and Mr. Schofield not present at the time of vote.

At this time Mr. Hickey moved that Assembly Standing Rule 92 be temporarily suspended regarding five day notice on passing the bills and on all other bills for the duration of this 58th Session be exempted from this standing rule. This was seconded by Mr. Demers and carried the committee unanimously.

AB 640 - Mr. Getto moved that this bill be "Indefinitely Postponed". This was seconded by Mr. Harmon and carried the committee with Mr. Demers voting "no" and Mr. Schofield not present at the time of vote.

This concluded the business of this meeting so it was adjourned at 4:10 P.M.
