Mr. Demers called the meeting to order at 7:55 a.m. Mr. Demers announced that he and Mr. Sena would act on bills with the consent of the excused members. He announced the first bill to be heard would be S.B. 411.

Mr. Adams spoke on the bill and stated that it was introduced at the request of the Nevada League of Cities. This bill requires filing of notice of intent and modifies recall procedures. He stated the purpose is in the recall process to have filed notice of intention to file the recall so that there is a time limit involved in the working of the petition. In Las Vegas, in the last recall, it took 60 to 90 days to get this accomplished. There are some places where the petitions are still outstanding, in Caliente, Carson City, where they run beyond the 60 day period. If a definite time period is set, you can note that at the end of that time period, we know that the petition will hold up in court.

Mr. Demers announced the next bill to be considered is <u>S.B. 592</u>. This bill requires candidates for partisan elective offices to indicate party affiliation on campaign materials.

Mr. Demers touched briefly on <u>S.B. 335</u> which he stated has a companion bill called <u>A.B. 294</u>. Mr. Adams stated that it was a good bill, for it sets up campaign expenses. For instance, the mayor of

Las Vegas will need more money for a campaign than the mayor of Ely, Nevada.

The following bills were voted upon. Mr. Demers stated that he would consult with the other members of the committee on the bills to be sure they were in agreement.

- S.B. 335 This bill limits campaign expenses of candidates for specified state, county and city offices and requires reports of such expenses. Mr. Demers made the motion to pass the bill. Mr. Sena seconded the motion.
- S.B. 411 This bill requires filing of notice of intent and modifies recall procedures. Mr. Demers made the motion to pass the bill. Mr. Sena seconded the motion.
- S.B. 592 This bill requires candidates for partisan elective offices to indicate party affiliation on campaign materials. Mr. Demers made the motion to pass the bill. Mr. Sena seconded the motion.

Mr. Demers announced there would be no further bills taken up this session and the Elections Committee is officially closed. The meeting adjourned at 8:05 a.m.
