The committee next discussed <u>S.B. 595</u>. Mr. Schofield moved for a do pass. The committee then discussed the bill. Mr. Schofield withdrew his motion for a do pass.

The committee next discussed <u>S.B. 6</u>. Mr. Young stated that <u>A.B.</u> <u>511</u> takes care of this. Mr. May suggested that the committee hold this bill a little longer.

Mr. Dini stated that there was a letter of intent with regard to <u>A.B. 770</u> which was addressed to Mr. Roland Westergard which he would like committee approval on. Mrs. **E**ORD moved that the committee do pass the letter (with a small amendment). A copy of the letter is Assembly Committee on Government Affairs

Dear Mr. Westergard:

It has been brought to the attention of the Assembly Government Affairs Committee that there is a great deal of concern in Southern Nevada about the future of the badly overdrafted underground basin in the Las Vegas Valley. This concern caused the drafting of A.B. 770 in the 1975 Session; however, the lateness of the introduction prevented hearings and action on the bill.

It is the desire of the Assembly Committee on Government Affairs that some attention, through study and discussion between interested parties, be directed at working out, prior to the 1977 Session, some legislative proposals addressed to this problem.

Therefore, we would request that you and your staff review A.B. 770 and submit to this committee no later than December 31, 1975, your comments on the proposed legislation, problems you see in its implementation if passed, and suggested alternative courses of action. Following that report, we would request that you arrange a meeting with those members of our committee residing in Clark County for the purpose of discussing this matter and hopefully arriving at a consensus on legislative proposals to be considered in 1977.

Thank you for your attention to this matter.
