## $\frac{\text{MINUTES}}{\text{OF}}$ SPECIAL MEETING

April 14, 1975

This Special Meeting of the Assembly Judiciary Committee was called to order by Chairman Barengo at the hour of 7:00 p.m. on Monday, April 14, 1975. The purpose of this meeting was to take action on bills, and at all times a quorum was present for voting. No Legislative Action Forms are attached to these Minutes.

As to <u>A.B.192</u>, a motion was made to DO PASS AS AMENDED. This motion was seconded. There were 7 Committee members in favor of this motion and 2 absent from the meeting at this time.

MOTION CARRIED DO PASS A.B.192 AS AMENDED.

A motion was made to DO PASS S.B.215 AS AMENDED. This motion was seconded. 6 voted in favor of this motion, 1 against (Mr. Lowman), and 2 Committee members were absent during the vote.

MOTION CARRIED DO PASS S.B.215 AS AMENDED.

Regarding S.B.319, a motion was made to DO PASS, and a second was made to the motion. The vote showed 7 in favor of passage with 2 absent for the vote.

MOTION CARRIED DO PASS S.B.319.

As to <u>S.B.351</u>, there was a motion to DO PASS, with a second to that motion. A vote indicated there were 7 in favor of passage. There were 2 members of this Committee absent for this vote.

MOTION CARRIED DO PASS S.B.351.

As to A.B.357, Mr. Sena moved INDEFINITE POSTPONEMENT, and Mr. Lowman seconded. The vote indicated 7 members of this Committee in favor of indefinite postponement, 1 dissenting (Mr. Heaney), and 1 member of the Committee absent during this vote.

MOTION CARRIED INDEFINITELY POSTPONE A.B.357.

Regarding S.B.214, Mr. Lowman moved to INDEFINITELY POSTPONE, with Mr. Hickey seconding this motion. A vote showed 7 in favor of this motion, 2 dissenting (Mr. Heaney and Mrs. Hayes), and 1 absent.

MOTION CARRIED INDEFINITELY POSTPONE S.B.214.

A motion was made to DO PASS AS AMENDED A.B.399. Discussion was had. The vote was 8 in favor of the motion, and 1 absent.

MOTION CARRIED DO PASS A.B.399 AS AMENDED.

Mr. Lowman moved DO PASS S.B.53 AS AMENDED. Mrs. Hayes seconded. The vote indicated 7 in favor of this motion, with 1 dissenting (Mrs. Wagner). 1 Committee member was absent during this vote. MOTION CARRIED DO PASS S.B.53 AS AMENDED.

There was a motion and a second to it to INDEFINITELY POSTPONE S.B.196. A vote showed 8 in favor of this motion, with 1 absent. MOTION CARRIED INDEFINITELY POSTPONE S.B.196.

Mr. Lowman moved to INDEFINITELY POSTPONE A.B.391, and Mr. Polish seconded. 7 voted in favor of the motion. 1 dissented (Mr. Hickey). 1 was absent.

MOTION CARRIED INDEFINITELY POSTPONE A.B.391.

As to A.B.392, Mr. Heaney moved to INDEFINITELY POSTPONE, and Mrs. Wagner seconded. The vote showed 7 in favor of the motion, 1 against (Mr. Hickey), and 1 absent.

MOTION CARRIED INDEFINITELY POSTPONE A.B.392.

As to S.B.196, Mr. Lowman moved to INDEFINITELY POSTPONE. Mr. Heaney seconded the motion. The vote indicated two in favor of the motion, 4 against, and 3 not present at the meeting during the voting. This motion did not carry.

Mr. Lowman moved DO PASS A.B.19 AS AMENDED. Mr. Heaney seconded the motion. The limit established by this Committee to be changed was to \$3,000. The vote indicated 7 in favor of the motion, and 2 members of the Committee were absent during the vote.

MOTION CARRIED DO PASS A.B.19 AS AMENDED.

Mr. Hickey moved to INDEFINITELY POSTPONE A.B.305, and Mrs. Hayes seconded. 5 voted in favor of indefinite postponement, 2 dissented (Mr.Lowman & Mr.Heaney), 1 abstained (Mrs.Wagner), and 1 was absent. MOTION CARRIED INDEFINITELY POSTPONE A.B.305.

As to S.B.294, Mr. Heaney moved DO PASS with Mr. Hickey seconding. The vote was 8 in favor of passage with 1 absent.

MOTION CARRIED DO PASS S.B.294.

Mr. Hickey moved DO PASS A.B.451, and Mrs. Hayes seconded. The vote showed 8 in favor of the motion with 1 absent. (Note: Mr. Hickey told the Committee that the county and city favored passage.)
MOTION CARRIED DO PASS A.B.451.

Mr. Heaney requested a Committee introduction of a bill dealing with school discipline. Discussion was had, and a motion was made for Committee introduction of the bill. The motion was seconded. 8 were in favor of the introduction. 1 Committee member was absent during this vote.

Mr. Lowman requested this Committee to introduce two bills dealing with medical malpractice. Discussion followed as to this introduction, and after a motion and a second, a vote was had. 8 Committee members voted in favor of Committee introduction of these 2 bills. 1 Committee member was absent for this vote.
