SPECIAL MEETING

May 16, 1975

This special meeting was called at the hour of 3:45 p.m. by Chairman Barengo, Chairman of the Assembly Judiciary Committee.

MEMBERS PRESENT: BARENGO, HAYES, HEANEY, HICKEY,  
LOWMAN, POLISH, SENA & WAGNER.

MEMBERS EXCUSED: BANNER.

A.B.786 was discussed by James Bilbray, and he suggested that he and Las Vegas City Attorney Carl Lovell get together tonight and work out something appropriate and acceptable to both to present to this Committee.

S.B.339 was discussed at length, and the proposed amendments were considered. (1.) The various amending language to cure the NIC's problems. (2.) To include the heart bill in this bill. Mr. Hickey moved to accept the first proposed amendment for S.B.339 and Mr. Sena seconded. The vote indicated 8 in favor of accepting this amended language. (Mr. Banner absent for the vote.) Mr. Hickey moved to add the second proposed amendment to this S.B.339. Mr. Sena seconded. Discussion was had and a vote followed, which indicated 5 in favor of incorporating the second amendment. 3 voted against this motion--Lowman, Wagner and Heaney. (Mr. Banner was absent for this vote.)

Mr. Heaney moved DO PASS S.B.339 with the first amendment incorporated, and Mr. Sena seconded. 7 voted for this motion. Mr. Lowman dissented. Mr. Banner was absent. Form attached.

MOTION CARRIED DO PASS S.B.339 AS AMENDED.

Frank Daykin was present to discuss S.B.369. He explained the cash price differential. He feels it is reasonable because it amounts to treating your automobiles as other goods are treated, because they are not covered under the Commercial Code at the moment, as they have been set aside in a separate category. Mr. Heaney moved DO PASS AS AMENDED, and Mrs. Wagner seconded. 7 voted in favor of the motion with 1 opposed--Lowman. Mr. Banner was absent. Form attached.

Bob Warren, League of Cities, discussed A.B.787, and said that at the present time this bill reads that a person has 20 days to do something about a libelous or slanderous statement or statements. If nothing is done within 20 days, he loses his rights to collect special damages. They feel that 20 days is too short a period of time. A person may not realize immediately that this statement may cause him problems and/or damage. They feel that perhaps 90 days may be a better time period. This Committee questioned Mr. Warren.

Mr. Hickey moved DO PASS A.B.787 AS AMENDED, and Mr. Lowman seconded. 8 voted in favor of this motion, and Mr. Banner was absent.  
MOTION CARRIED DO PASS A.B.787 AS AMENDED.

There being no further business at this time, and after a motion and a second, Chairman Barengo adjourned this meeting.
