

March 13, 1975

The meeting was called to order at 1:40 P.M., by Chairman Banner for the purpose of the Committee only reviewing and acting upon A.B.'s 219 & 287 & 241 & 315.

Discussion was held on A.B. 287, after which Mr. Schofield made a motion to adopt the proposed amendments on the bill. Mrs. Hayes seconded the motion. All members present voted "aye" with the exception of Mr. Getto, who did not vote. Mr. Schofield made a motion that the bill be given a "do pass as amended" recommendation. Mrs. Hayes seconded the motion. All members present voted "aye" with the exception of Mr. Getto, who did not vote.

Discussion was held on A.B. 241, after which Mr. Moody made a motion that the bill be given a "do pass" recommendation. The motion was seconded by Mr. Schofield. All members present voted "aye".

Discussion was held on A.B. 315, after which Mr. Schofield made a motion that the bill be redrafted with the following changes.

- 1--Section 1, Line 6--Delete the word "compensation".
- 2--Section 1, Line 8--Delete the word "compensation".
- 3--Section 2, Line 13--Delete the words "on each payday" and replace them with the words "upon request".
- 4--Section 4, Line 16--Delete the word "deliberately" and replace it with the word "willfully".
- 5--Section 5, Lines 19 & 20--Delete entirely.

The motion was seconded by Mr. Benkovich, and the Committee voted unanimously to have the bill redrafted, with the above changes.

Discussion was held on A.B. 219, after which Mr. Schofield made a motion that a "do pass, as amended by amendment #5485" recommendation be given the bill. The motion was seconded by Mr. Benkovich. The vote was unanimous in favor of the motion.

Mr. Schofield made a motion that Mr. Benkovich be given permission to draft a new bill, concerning a 2-hour overtime provision, which was originally intended as an amendment to A.B. 219. The motion was seconded by Mrs. Hayes. The vote was unanimous in favor of the motion.

Mr. Schofield moved to adjourn the meeting. Seconded by Mrs. Hayes. The meeting was adjourned by Chairman Banner at 2:45 P.M.
